The City Council, City of Fairhope, met in an organizational session at 6:00 p.m., Fairhope Municipal Complex Council Chamber, 161 North Section Street, Fairhope, Alabama 36532, on Monday, 5 November 2012.

Present were Councilmembers: Jack Burrell, Rich Mueller, Diana Brewer, Michael A. Ford, and Kevin Boone, Mayor Timothy M. Kant, City Attorney Marion E. Wynne, and City Clerk Lisa A. Hanks.

There being a quorum present, City Clerk Lisa Hanks took the seat as presider and called the meeting to order. The invocation was given by Deacon George Yeend from St. Lawrence Catholic Church and the Pledge of Allegiance was recited.

This being the organizational meeting to begin the new administration, Mayor Kant, and the newly-elected Councilmembers, Jack Burrell, Rich Mueller, Diana Brewer, Michael A. Ford, and Kevin Boone, prepared to take their Oath of Office.

The Honorable James H. Reid, Circuit Judge, 28th Judicial Circuit of the State of Alabama, then gave the Oath of Office to the new Council: Mayor Kant; Councilmembers Burrell (Place # 1); Mueller, (Place # 2); Brewer, (Place # 3); Ford, (Place # 4); and Boone, (Place # 5). (Signed Oaths inserted at end of these minutes.)

The new administration took their seats on the dais and continued with business.

Ms. Hanks conducted the procedures for electing a Council President and Council President Pro Tempore. The floor was opened for Council President nominations. Councilmember Ford nominated Councilmember Burrell. Seconded by Councilmember Boone and no other nominations were made. The floor for nominations was then closed. Councilmember Burrell was elected Council President unanimously by voice vote.

The floor was then opened for Council President Pro Tempore nominations: Councilmember Mueller nominated Councilmember Ford. Seconded by Councilmember Brewer and no other nominations were made. The floor for nominations was then closed. Councilmember Ford was elected Council President Pro Tempore unanimously by voice vote.

Council President Burrell took the presider's seat and continued with business after making an opening statement. He then opened the floor to the audience for comments.

Mike Odom with the Fairhope Courier addressed the City Council regarding public participation not being before the resolutions, ordinances, and other items; and encouraged the Council to consider moving this section. He thanked the Council for allowing him to speak.

Joe Birindelli, Grand Avenue, addressed the City Council regarding the Veterans Day Parade and invited them to participate in the parade on Saturday at 10:00 a.m.

Paul Ripp, High Ridge Road, addressed the City Council and congratulated them as new Councilmembers. He mentioned that people will be watching for you to fail. He also said they should not contract with other public officials and said they need to look at the Planning Commission.

Councilmember Ford introduced in writing Ordinance No. <u>1479</u>, an ordinance to adopt the Rules of Procedure in all instances for meetings of the City Council. The ordinance was briefly explained by Council President Burrell. He said that more public participation was added not decreased. We moved the work session to 4:30 p.m. prior to each Council meeting. City Attorney Wynne said they could move items and amend procedures.

In order to take immediate action, Councilmember Boone moved for immediate consideration. Seconded by Councilmember Brewer, motion for immediate consideration passed unanimously by the following voice votes: AYE – Burrell, Mueller, Brewer, Ford, and Boone. NAY - None.

Councilmember Ford moved to amend Section 9. The order of business by adding public participation for agenda items after Report of the Mayor and keep Public Comments at the end of the meeting. Seconded by Councilmember Mueller, the motion to amend passed by the following voice votes: AYE - Burrell, Mueller, Brewer, Ford, and Boone. NAY - None.

Councilmember Brewer then moved for final adoption of Ordinance No. <u>1479</u> as amended. Seconded by Councilmember Brewer, motion for final adoption passed by the following voice votes: AYE - Burrell, Mueller, Brewer, Ford, and Boone. NAY - None.

Councilmember Ford introduced in writing Ordinance No. <u>1480</u>, an ordinance to repeal Ordinance No. 1378, Ordinance No. 1391, and Ordinance No. 1419 which established the positions of City Administrator and Utility Superintendent. In order to take immediate action, Councilmember Boone moved for immediate consideration. Seconded by Councilmember Mueller, motion for immediate consideration passed unanimously by the following voice votes: AYE - Burrell, Mueller, Brewer, Ford, and Boone. NAY - None.

Councilmember Brewer then moved for final adoption of Ordinance No. <u>1480</u>. Seconded by Councilmember Boone, motion for final adoption passed by the following voice votes: AYE - Burrell, Mueller, Brewer, Ford, and Boone. NAY - None.

Councilmember Boone introduced in writing Ordinance No. <u>1481</u>, an ordinance to authorize Mayor Timothy M. Kant to act as full-time Utility Superintendent. In order to take immediate action, Councilmember Mueller moved for immediate consideration. Seconded by Councilmember Ford, motion for immediate consideration passed unanimously by the following voice votes: AYE - Burrell, Mueller, Brewer, Ford, and Boone. NAY - None.

Councilmember Brewer asked Mayor Kant to explain the duties and why we need this position. Mayor Kant stated that he was already the job and the money is paid from the Utilities; and he is the manager of the entire City which includes the three managers of the utilities. The decision to fill the position is up to the Council and they have the discretion to remove at any time. Council President Burrell read the following from the ordinance and said the salary is \$60,000 yearly:

The City Council may at any regular meeting or special meeting called therefore, discontinue the services of the Mayor as Superintendent of the utility system, and in the event of such discontinuance of his services as such Superintendent of such system, all compensation authorized to be paid in Section 2 hereof shall lapse.

Councilmember Ford then moved for final adoption of Ordinance No. <u>1481</u>. Seconded by Councilmember Boone, motion for final adoption passed by the following voice votes: AYE - Burrell, Mueller, Brewer, Ford, and Boone. NAY - None.

Councilmember Brewer introduced in writing, and moved for the adoption of the following resolution, a resolution authorizing signees of all City of Fairhope Accounts. Seconded by Councilmember Mueller, motion passed unanimously by voice vote.

Council President Burrell addressed the City Council and thanked everyone. He said we would work hard for you and the employees of the City. He thanked the City Council for their hard work since being elected. He thanked the staff and thanked the Mayor for being accessible.

There are three groups that make Fairhope what it is: the citizens, the elected officials, and the City employees. He thanked the Council for approving the budget. He said the monies are there and you must decide how to spend it. There is a one-time \$375,000 for education and \$450,000 for recreation. The K-1 playground is in limbo and we need to move forward. He would like to see the playground accessible for special needs children. He would like to see a Performing Arts Center. He told the Council to remember his doors are always open. Mayor Kant said he wanted to thank his wife Karla for putting up with all of this.

Council President Burrell stated he wanted to echo that he would like to see a Financial Advisory Committee in the near future. He said the Council has the ultimate decision, but it would be nice to have advice on issues.

Council President Burrell mentioned that Rick Kingrea's wife, Debbie, had passed away this weekend; and asked for everyone to keep Rick Kingrea and their family in our thought and prayers.
