The City Council, City of Fairhope, met in regular session at 6:00 p.m., Fairhope Municipal Complex Council Chamber, 161 North Section Street, Fairhope, Alabama 36532, on Monday, 9 July 2012.

Present were Council President Lonnie L. Mixon, Councilmembers: Debbie W. Quinn, Daniel Stankoski, and Michael A. Ford, Mayor Timothy M. Kant, City Attorney Marion E. Wynne, and City Clerk Lisa A. Hanks. Councilmember Rick Kingrea was absent.

There being a quorum present, Council President Mixon called the meeting to order. The invocation was given by Ryan Kramer from St. Paul's Lutheran Church and the Pledge of Allegiance was recited.

Erik Cortinas, Commissioner of Fairhope Baseball, addressed the City Council regarding the Ozone Tournament being held in the City at Volanta Park. He mentioned Phil Savage would be the keynote speaker. The tournament begins Friday with a banquet and opening ceremony. Play begins at 12:30 p.m. Mr. Cortinas asked Mayor Kant and the Councilmembers to be their guests for the Ozone Tournament.

Council President Mixon asked if there were any corrections to the minutes from the 25 June 2012, regular meeting. He then stated if there are no corrections, the minutes stand approved as written.

Council President Mixon asked if there were any corrections to the minutes from the 25 June 2012, work session meeting. He then stated if there are no corrections, the minutes stand approved as written.

Mayor Kant addressed the City Council regarding the following items:

- 1) Restore Act was passed and signed by the President with approximately 1 billion dollars going to Mobile and Baldwin Counties. A certain percentage is for environmental and large percentage economic development.
- 2) The AMEA voted to give \$5,000 grant to the Fairhope Youth Baseball for this tournament.
- 3) The Eastern Shore Metropolitan Planning Organization voted to give the City of Fairhope an additional voting member; and a resolution is on the agenda to be approved by the City Council.
- 4) City Clerk Lisa Hanks was recognized for being nominated for Clerk of the Year. She was one of seven clerks nominated out of the State. He thanked Ms. Hanks and said her peers are the ones who make the nomination.

5) The moratorium ordinance was mentioned which is on the agenda for the City Council to consider. He said instead of rushing the judgment we should slow down the process.

Council President Mixon added that District VIII nominated Ms. Hanks which consists of clerks from Baldwin, Escambia, Mobile, and Washington Counties; so it was not just a local thing. He said so congratulations to Ms. Hanks on that.

Council President Mixon read a letter from Sheila Robinson, supervisor of the MS Gulf Coast Coliseum and Convention Center for a job well done by the Police Department during the Fourth of July Celebration at the beach.

Council President Mixon stated that from time to time Department Heads are asked to give updates on their departments. Chief Bill Press was asked to give a Departmental Report. Chief Press addressed the City Council and gave a detailed summary of personnel issues he has dealt with since coming to the City of Fairhope. Ten cases were mentioned dealing with violations of personnel policies. A copy of the report is on file with the City Clerk's office.

Councilmember Quinn said the Chief has done an outstanding job against a lot of adversity. Councilmember Stankoski stated prior to the Chief coming he had been contacted by and also met with several officers regarding promotion disparity, discipline, and other allegations were mentioned. Councilmember Stankoski concurred with the statements Chief Press made.

Councilmember Ford addressed the City Council regarding the following items:

- 1) Reverend Henry and the Baptist Church should be commended for putting on that fine performance during the Fourth of July celebration.
- 2) Tattoo Parlor issue, we should give a temporary license and then make a decision. In the interest of fairness, there were others who wanted to speak on the other side of the issue and were cut off; we need to let the discussion continue.

Councilmember Quinn addressed the City Council regarding the Citizens for Responsible Government's forum was pulled at their request and there will not be a forum for candidates. She asked for an update on the contract with Volkert for the sewer system. Mayor Kant replied that the contract had been signed and they were already working.

Council President Mixon addressed the City Council and commented that he would not be running for re-election and I won't be here for the next session. He said if the new council chooses not to appoint Chief Press, they are making a terrible mistake for the City of Fairhope.

Councilmember Ford moved to address the following item **not** on the printed agenda. There was no second to the motion; Council President stated the ordinance will not be added to the agenda. Councilmember Ford said the people should be allowed to speak; and we should give a temporary license for the tattoo parlor. Mayor Kant called for a point of order and stated that if the City Council did not adopt the ordinance tonight, this issue would go before the Board of Adjustments on Monday night. Council President Mixon stated this item will go before the Board of Adjustments for review on July 16, 2012; it needs to take its normal progress through the law. After further discussion, the motion to add to the ordinance to the agenda was seconded by Councilmember Quinn, motion passed unanimously by voice vote.

Councilmember Ford introduced in writing an Ordinance to Protect the Health, Safety and General Welfare of the People by Declaring a Moratorium on the Issuance of Business Licenses for Body Art/Tattoo Studios, Permanent Make-Up Establishments, Body Piercing Facilities, and Adult Entertainment Businesses within the Corporate Limits of the City of Fairhope, Alabama. Due to no motion for immediate consideration, this ordinance will layover until the July 23, 2012 City Council meeting.

Councilmember Quinn moved to take an intermission from the regular City Council meeting and continue the work session. Seconded by Councilmember Ford, motion passed unanimously by voice vote.

The following individuals spoke during Public Participation regarding the proposed tattoo parlor and the ordinance declaring a moratorium on the issuance of business licenses for body art/tattoo studios, permanent make-up establishments, body piercing facilities, and adult entertainment businesses within the Corporate Limits of the City of Fairhope, Alabama:

- 1) Amy Stubler, 209 Magnolia Avenue, addressed the City Council and voiced her opinion against allowing the proposed tattoo parlor in a residential area.
- 2) Melly Wirtes, 136 Pemberton Loop, addressed the City Council and voiced her opinion for allowing the proposed tattoo parlor in a residential area.
- 3) Paul Ripp, 22985 Highridge Road, addressed the City Council and voiced his opinion for allowing the proposed tattoo parlor in a residential area.
- 4) Pete Blohme, 92-1/2 S. Section Street and owner of Panini Pete's, addressed the City Council and voiced his opinion for allowing the proposed tattoo parlor in a residential area.
- 5) Kyle Brady, 355 Equity, addressed the City Council and voiced his opinion for allowing the proposed tattoo parlor in a residential area.

Council President Mixon commented Mr. Black has gone through the proper steps; and now it will go back to the Board of Adjustments and run its course.

City Attorney Wynne stated that this will be appealed to the Board of Adjustments and if it is denied, Mr. Black would appeal to the Circuit Court.

Jonathan Smith, Director of Planning and Building, addressed the City Council and said this is a land use issue that will affect all areas in the City. When uses are not defined in the Zoning Ordinance, it must go before the Board of Adjustments. This item was tabled for further discussion and notice.

6) Jonas Libor addressed the City Council and voiced his opinion for allowing the proposed tattoo parlor in a residential area.

The regular City Council meeting resumed after a short intermission.

City Administrator Gregg Mims addressed the City Council on the following items:

- 1) Annual review from our Worker's Compensation folks was mentioned. Department Heads should be commended for our Bronze Safety Award. One of the suggestion was to have a Safety Committee Policy Statement was presented and briefly mentioned.
- 2) Recommendations for Fairhope Emergency Alert Notification System was presented and briefly mentioned.
- 3) Building Permits update was given from January 2012 to June 2012; 102 single family residential permits which are 32 permits up from last year at this time.

City Administrator Mims addressed the City Council and briefly explained Agenda Items Number 6 through Number 18 prior to the City Council voting on same.

Councilmember Stankoski moved to appoint Patrick Waldrop to the Tree Committee for a three-year term. The term will expire in July 2015. Seconded by Councilmember Quinn, motion passed unanimously by voice vote.

Councilmember Ford introduced in writing, and moved for the adoption of the following resolution, a resolution authorizing the Mayor and the Council President to represent the City of Fairhope in all matters pertaining to the Eastern Shore Metropolitan Planning Organization as the two voting members. Seconded by Councilmember Stankoski, motion passed unanimously by voice vote.
