The City Council, City of Fairhope, met in regular session at 6:00 p.m., Fairhope Municipal Complex Council Chamber, 161 North Section Street, Fairhope, Alabama 36532, on Monday, 13 February, 2012.

Present were Council President Lonnie L. Mixon, Councilmembers: Debbie W. Quinn, Daniel Stankoski, Michael A. Ford, and Rick Kingrea, Mayor Timothy M. Kant, City Attorney Marion E. Wynne, and City Clerk Lisa A. Hanks.

There being a quorum present, Council President Mixon called the meeting to order. The invocation was given by Deacon George Yeend of St. Lawrence Catholic Church and the Pledge of Allegiance was recited. Council President Mixon asked if there were any corrections to the minutes from the 23 January 2012, regular meeting. He then stated if there are no corrections, the minutes stand approved as written.

Council President Mixon asked if there were any corrections to the minutes from the 23 January 2012, work session meeting. He then stated if there are no corrections, the minutes stand approved as written.

Council President Mixon recognized Tom Kuhl, Parks & Recreation Director, for the City of Fairhope's field, W. C. Majors Field at Volanta Park, being selected as one of the ninety-one fields honored with the "2011 Fields of Excellence Award" out of a pool of over 250 applicants. The Fields of Excellence award program honors outstanding athletic fields and the hard working field crews who diligently maintain them. Council President Mixon said thank you and congratulations to Tom Kuhl and his crew for doing such a good job.

Mayor Kant addressed the City Council on the following items:

- 1) House Bill 74 which is being introduced by Steve McMillan and deals with taking away our Planning District outside our corporate limits. He asked everyone to let him know their thoughts on the issue and he would voice their concerns to our Senator.
- 2) Eddie Hall and Ken Eslava are here tonight. Ken Eslava is now over the fleet maintenance with the City. Out front is a 1988 flatbed truck which has been refurbished and painted by Eddie Hall. This truck was a bucket truck retired from the Electric Department with only 13,000 miles. Mr. Hall took the bucket truck and refurbished into a flatbed truck and painted it which now looks new for a cost of around \$1,300. This was a good opportunity to show the Council some of the talent we have in Fairhope.

3) The report on New Year's Eve and the report from the accident with the Electric Department were requested. Mayor Kant stated we are in the process of implementing safety coordination which is being handled by Gregg Mims.

Councilmember Ford addressed the City Council and reiterated that the field looks great. He also thanked Tom Kuhl and his crew.

Councilmember Stankoski addressed the City Council and stated he echoed the comments regarding the field. He mentioned that he stated how great the field looked for the Senior Bowl practice and obviously it does.
