**THE DOCUMENTS FOR THIS BID SHALL BE AMENDED, REVISED AND CHANGED IN THE FOLLOWING PARTICULARS:**

**CLARIFICATION:**

1. Based on contract book (under Special Conditions) and plans (Sheet C2 note 23), it states the project is to be in accordance with ALDOT 2012 Spec Book. Is that correct?  
**Yes.**
2. If per ALDOT 2012, Asphalt pay items 424A and 424B are paid per TON instead of SY. Will this be changed? If not, how will you tie this to the Asphalt Index (if the project is indexed)?  
**No, these items to be paid by SY.**
3. Will all Bituminous items be tied to the ALDOT monthly index?  
**No.**
4. Borrow Excavation pay items states "Loose Truckbed Measure" but the pay item unit is CYIP. Will this pay item be CYTM?  
**Pay item unit revised to CUYD (TBM).**
5. Roadbed Processing – If ALDOT spec, will it be paid per Station instead of SY?  
**No, Paid per SY.**
6. Remove and Reset Concrete Parking Bumpers – We have noticed many damaged or broken parking bumpers (N. Beach, Masonic Dr, Armory, Fire Station on Ingleside). Do you want broken/damaged ones replaced? If so, do you intend to setup a pay item for these?  
**Yes, pay item added, 627D Precast Concrete Parking Bumpers.**
7. Topsoil – It is showing be paid CYIP. No thickness noted. Will this be paid CYTB instead?  
**Pay item unit revised to CUYD (TBM).**
8. In back of Contract book, there is a Roofing Guarantee and Asbestos Affidavit. These don't apply to this project correct?  
**Roofing guarantee and asbestos affidavit do not apply. These are just part of the City's standard contracts.**
9. Do you have milling for tie-ins (at beginning and end of streets and on side streets) included in the milling pay item on roads that show overlay only?  
**No, milling for tie-ins for streets with overlay only to be paid as subsidiary item to pay Item 424A.**
10. On Page C4 for Founder's Park, there is a discrepancy in the Asphalt paving detail regarding thickness of asphalt. How thick to you want the asphalt?  
**1.5 " thick, 165 LB/SY.**
11. On Manhole Cover Resets, are riser rings acceptable?  
**Yes, pay item split into two items: 622A-1 Manhole Covers Reset (ring & cover) and 622A-4 Manhole Covers Reset (Riser Ring method).**

12. On Valve Box Resets, are drop in risers acceptable?

**Yes.**

13. Will Machine Grade Shoulders be required on streets without Curb and Gutter? If so, how will it be paid?

**Yes, machine grading of shoulders shall be a subsidiary obligation of 424A, any additional topsoil to be paid as CUYD (loose truck bed measure), 650A.**

14. On Masonic Drive, De La Mare Ave, and S. School St., will we be allowed to shut down these areas for Resurfacing?

**Yes, contractor to coordinate with City of Fairhope Public Works Director and Project Engineer.**

15. On Beach Drive, sand is covering a lot of the parking spots. Will the removal of the sand be subsidiary of an existing pay item?

**No, pay item added: 206F Removal of Sand and Cleaning of Beach Drive Area, Lump Sum.**

16. Added pay item, 701A-2.3 Solid White, Class 2, Type A Traffic Stripe 8" thick.

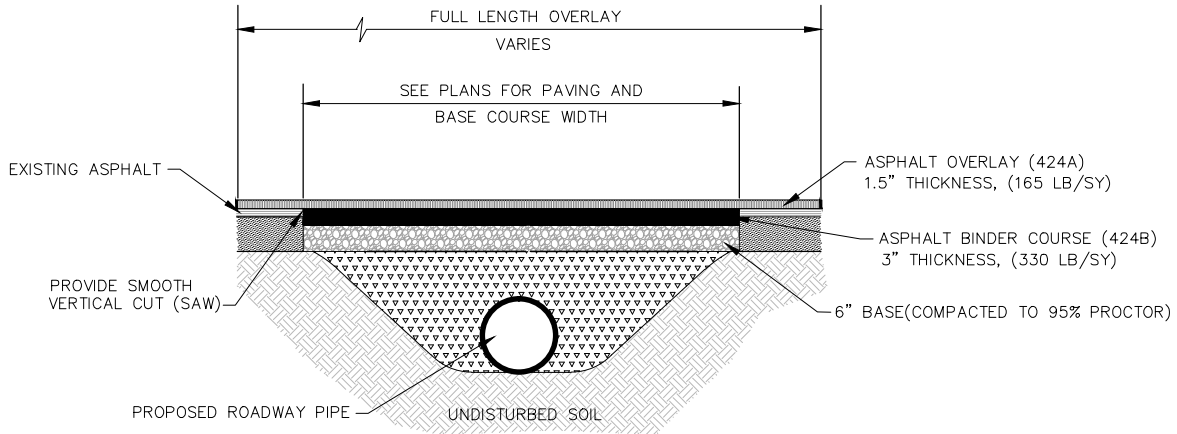

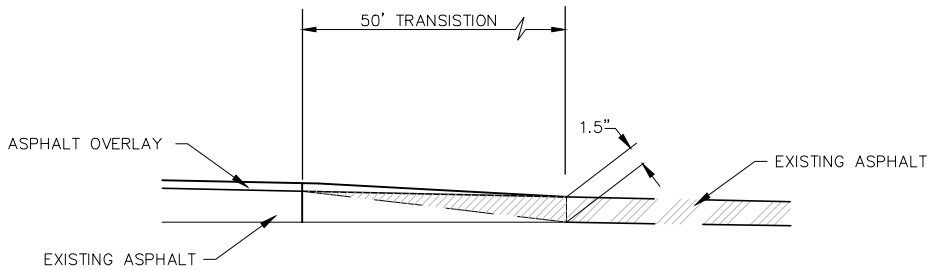

### ASPHALT ROADWAY PATCH DETAIL

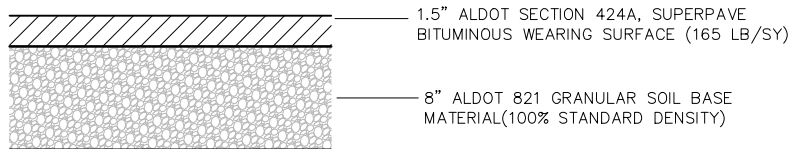
