The City Council, City of Fairhope, met in regular session at 6:00 p.m., Fairhope Municipal Complex Council Chamber, 161 North Section Street, Fairhope, Alabama 36532, on Monday, 25 January 2016.

Present were Council President Jack Burrell, Councilmembers: Rich Mueller, Diana Brewer, Michael A. Ford, and Kevin Boone, Mayor Timothy M. Kant, City Attorney Marion E. Wynne, and City Clerk Lisa A. Hanks.

There being a quorum present, Council President Burrell called the meeting to order. The invocation was given by Deacon George Yeend of St. Lawrence Catholic Church and the Pledge of Allegiance was recited. Councilmember Boone moved to approve minutes of the 11 January 2016, regular meeting; minutes of the 11 January 2016, work session; and minutes of the 11 January 2016, agenda meeting. Seconded by Councilmember Brewer, motion passed unanimously by voice vote.

Mayor Kant addressed the City Council and announced the Senior Bowl's South Team practice and signing of autographs. He mentioned a meeting with Byard for possible grants and trails; and tomorrow he will testify in front of the Transportation Committee.

The following individual addressed the City Council during Public Participation for Agenda Items:

- 1) Elizabeth Hammock, 254 N. Bayview Street, addressed the City Council regarding Agenda Item Number 22, a resolution authorizing Mayor Kant to execute a contract for professional consulting services with The Akribos Consulting Group to prepare the Comprehensive Education Study with a cost not to exceed \$49,000.00. She said this is an opportunity for a third party to get us information to be online with other schools.
- 2) Kerry Flowers, 11 North Ingleside and Chairman of the Education Advisory Committee ("EAC"), addressed the City Council regarding Agenda Item Number 22 regarding the Comprehensive Education Study. Mr. Flowers said he appreciated the Mayor and the City Council for renegotiating; and for allowing this academic audit.
- 3) Kenneth McDowell, 29 Cottage Drive, addressed the City Council regarding Agenda Item Number 22 regarding the Comprehensive Education Study. He commended the Mayor for negotiating the amount of the study from \$80,000.00 to \$49,000.00. He also mentioned there were five schools in this community.
- 4) Katherine Goldman, 7059 Windmere Place, addressed the City Council regarding Agenda Item Number 22 regarding the Comprehensive Education Study. She said this study is a great opportunity for our children.

- 5) Molly Robertson, Main Street, addressed the City Council regarding Agenda Item Number 22 regarding the Comprehensive Education Study. She stated the condition of our schools is lacking; and the study is a good start for the community.
- 6) Bryan Injaian, owner of Accommodations Afloat, addressed the City Council regarding Agenda Item Number 10: an ordinance to approve an application for a Franchise Agreement to operate Sailing Charters and Overnight Rentals at the Fairhope Municipal Pier Marina. Mr. Injaian stated he had four to five captains in the area he may use along with his Dad. He thanked the City Council for considering his application.
- 7) Bryan Shue, 322 Poviner, addressed the City Council regarding Agenda Item Number 22 regarding the Comprehensive Education Study. He said this gives the City a closer look at our schools system and maybe the first step to solving issues.

LeeAnn May of Hartmann, Blackmon and Kilgore addressed the City Council and briefly went over the Comprehensive Annual Financial Report "CAFR" for the year ending September 30, 2015. Ms. May thanked the Mayor and City Councilmembers for allowing "HBK" to perform the audit. She also thanked the Treasury and Finance Departments for all of their help throughout the engagement.

Councilmember Mueller moved to accept the Comprehensive Annual Financial Report as presented. Seconded by Councilmember Boone, motion passed unanimously by voice vote.

Council President Burrell announced that Agenda Item Number 6; the presentation of the Quarterly Financial Report was pulled from the agenda and would be addressed at the next City Council meeting.

Councilmember Brewer introduced in writing an ordinance to approve the Zoning Map for the Colony at the Grand Tourism District which includes adding 1.9 acres as Low-Rise and changing 34.4 acres that was previously dedicated as Mid-Rise Zone to Low-Rise Zone to the Land Use Map for the Colony at the Grand. The Planning Commission gave a favorable recommendation of this ordinance. Council President Burrell read the proposed ordinance.

Planning Director Jonathan Smith briefly explained the proposed ordinance.

Council President Burrell opened the Public Hearing at 6:32 p.m. No one present opposed the proposed ordinance, the Public Hearing closed at 6:32 p.m.

Due to lack of a motion for immediate consideration, this ordinance will layover until the February 11, 2016 City Council meeting.

A Public Hearing was held as advertised on a proposed ordinance to amend Zoning Ordinance No. 1253, adopted 27 June 2005. Councilmember Brewer introduced in writing an ordinance to zone the property of The Teachers Retirement Systems of Alabama to Tourism Resort District concurrent with annexation into the City of Fairhope. This property is generally located on the west side of Section Street just north of Battles Road, Fairhope, Alabama. Parcel No. 05-46-09-30-0-000-078.001. <u>Azalea at the Colony</u>. The Planning Commission gave a favorable recommendation of this ordinance. Council President Burrell read the proposed ordinance.

Planning Director Jonathan Smith briefly explained the proposed ordinance.

Council President Burrell opened the Public Hearing at 6:37 p.m. No one present opposed the proposed ordinance, the Public Hearing closed at 6:37 p.m.

Due to lack of a motion for immediate consideration, this ordinance will layover until the February 11, 2016 City Council meeting.

A Public Hearing was held as advertised on a proposed ordinance to amend Zoning Ordinance No. 1253, adopted 27 June 2005. Councilmember Boone introduced in writing Ordinance No. 1563, an ordinance to rezone the property of St. Lucia Properties, LLC from R-2 Medium Density Single Family Residential District to B-3a Tourist Resort Lodging District. This property is generally located at 206 S. Mobile Street, Fairhope, Alabama. Parcel No. 05-46-03-37-0-010-041.000. The Planning Commission gave a favorable recommendation of this ordinance. Council President Burrell read the proposed ordinance.

Planning Director Jonathan Smith briefly explained the proposed ordinance; and said there was no opposition at the Planning Commission's meeting. Jeremy Lee, owner of the property, addressed the City Council and explained the proposed plan. He said it will be three-units that will be as high class as they can using local architects to design; and it will greatly benefit the community. Councilmember Brewer commended Mr. Lee and said this is a great plan.
