Position Description: General nature/purpose of work: The purpose of this position is to operate a City of Fairhope garbage truck which collects, and dumps refuse or recyclable materials from containers into the City truck and deposits the collected material at the City of Fairhope’s disposal site.

Primary responsibilities: The Equipment Operator III position is responsible for collecting and transporting solid waste along designated residential and commercial routes in a timely and efficient manner. Work is performed in accordance with established procedures developed by Public Works Department. Under the direction of the Sanitation manager, this position works independently, and may exercise supervision over others. This position is required to work late night and early morning shifts; Operates equipment that compresses collected refuse; Dumps refuse or recyclable materials at disposal sites; Refuels trucks or add other fluids, such as oil or brake fluid; Maintains vehicles in good working condition; Completes defective equipment reports; Communicates with dispatchers concerning delays, unsafe sites, accidents, equipment breakdowns, or other maintenance problems; Reports vehicle or equipment malfunctions; Notifies others of emergencies, problems, or hazards; Tags garbage to inform customers of problems such as excess garbage or inclusion of items that are not permitted.

Acceptable Education and Experience: Graduation from a standard senior high school, or the successful completion of the General Educational Development (GED) test;

SPECIAL REQUIREMENT: Must have and maintain a valid Alabama Driver’s License; CDL class B preferred
