# Question #1:

## Item III Paragraph 3.2

You list a 10,000-gallon Flameshield tank with UL-142, F921 & SwRi 97-04 labels. As I read the specs I noticed it is going to the marina at the dock to supply on unleaded gas and diesel: In the drawings and specs we noticed you have the pumps and dispensers mounted on the end of tank.

Are you sure this will meet specifications in this type setting with the Type products, pumping and dispensing Units mounted on the end of tank, and not a Fire protected FIRE RATED UL-2085 tank?

### Answer #1:

Item III, Paragraph 3.2:

Delete "Flameshield" tank with UL-142

Add UL-2085, "Fireguard" type tank.

## **Question #2**

### Item III Paragraph 3.2.1

In the specs I did notice you are calling for a single bulkhead to separate the two compartments for unleaded gas and diesel. A good practice in the industry, usually, is when you are separating two different type products like unleaded gas and diesel it is a good practice to use double bulkheads to separate the products. This is a extra precaution in case ever a leak occurs from one compartment to the next it helps to contain product and possible prevent contamination of products

#### Answer#2

The double wall baffle is required for this bid.

#### Question #3

In the bid package there is a statement that you will be required to buy a City of Fairhope license? Is that correct? We do not have an active salesman in Fairhope and the tank would be shipped on an outside carrier into Fairhope. If that is a hard and fast rule what is the cost of the license? It will have to be added into the bid.

### Answer #3

The City of Fairhope does have a delivery license. If goods delivered are between \$10,000 and \$75,000, the License fee is \$110.00 for the year. If gross receipts are over \$75,000, then cost of license is based on the classification of the delivered goods. This only pertains to companies that have no other presence in our City or Jurisdiction. If at any time, the vendor has someone from their company in our area working outside the realm of delivery and installation of that delivery, then they are subject to a license based on their classification.
