



# Quail Creek M.G.A. IRON-MAN



- Saturday Feb. 9th – 8:00 AM Shotgun Start

**FORMAT: Stroke Play – Maximum Double Par!** The 2012-2015 U.S.G.A. Rules of Golf and Decisions will govern play with the exception of the following Quail Creek Golf Course, local rules and conditions:

**Hole Locations are set “Severe” and are intended to be “penal”. See pin chart for hole locations**

**Participants will play from their normal tees.**

***NOTE TO COMPETITORS: The MGA Rules Committee shall announce to the field the conditions of play. If the Committee shall decide to play lift, clean and place (through the green or in the fairway of the hole being played) a ball is deemed to be in play when the player attempts a stroke, with the intent to strike.***

1. **Water Hazards:** All water hazards are deemed lateral and are red lines and designated red stakes. HOLE #5: Players, that do not negotiate the Water Hazard on the Tee Shot, may 1) Proceed Under Rule 24; and as additional option 2) Under penalty of One (1) Stroke use the designated Ball Zone located behind the Senior/Ladies Tee across the “spillway”.
2. **Out of Bounds:** Defined by White PVC Stakes; and by White Lines connecting stakes to stakes. White Lines take precedence over Stakes, when the White Line joins the two. A ball is Out of Bounds, when ALL of it lies out of bounds. White PVC Stakes, define Out of Bounds at the inside portion of the stake at ground level. White Lines define out of bounds by the inside “edge” of the line. OB also defined by the “inside edge” of curbing between the play of holes #1 & #2; #8 & #9; #15 & #16. A ball is OB, even though it may come to rest on another part of the golf course.
3. **Ground Under Repair (G.U.R.):** Any areas designated with White Lines in the fairways or roughs are deemed ground under repair. Please go to the nearest point of relief, no nearer to the hole. If a ball should come to rest in an area of Ground Under Repair: 1) The Player may play the ball as it lies; 2) The player may drop a ball at the nearest point of relief, no nearer to the hole. Tire ruts, caused by golf carts and maintenance equipment is considered damage and treated as abnormal ground condition and deemed G.U.R.
4. **Root Rule is in effect today. Free relief, 1 club length for roots interfering with swing. Lift, clean & drop.**
5. **Fire Ant Beds:** Ground Under Repair
6. **Embedded Ball Rule:** Is in effect, through the green.
7. **PUTTING GREEN:** On the Putting Green, if a ball comes to rest on an “aerification hole” on the putting green, a player may re-place the ball, no nearer to the hole, on a spot that allows relief from the “aerification hole”. No Penalty. Aerification Plugs are loose impediments
8. **Casual Water:** Casual water is any temporary accumulation of water on the course that is not in a water hazard and is visible before or after the player takes her stance. A ball is in casual water when it lies in or any part of it touches the casual water.
9. **Obstructions: Fairway Yardage PVC Poles** adjacent to the fairways (next to cart paths) are deemed Movable Obstructions. A “wash out area” immediately adjacent to a cart path is deemed to be part of the obstruction and a player may proceed under Rule 24-1. Small Stones in Bunkers are movable obstructions.
10. **Doubt as to Procedure:** In stroke play, if a competitor is doubtful of his rights or the correct procedure during the play of a hole, he may, without penalty, complete the hole with two balls. After the doubtful situation has arisen and before taking further action, the competitor must announce to his marker or a fellow competitor that he intends to play two balls and which ball he wishes to count if the Rules permit. If she fails to do so, the provisions of Rule 3-3b(ii) apply. The competitor must report the facts to the MGA Rules Committee of the incident, prior to returning a scorecard.
11. **Flights Determined by Bull Pen Point Quota.** Payout amounts determined by the number of entries.
12. **Meal After Play.**
