Sealed bids, subject to the conditions contained herein, will be received by **City of Fairhope, Alabama at 555 S. Section Street, Fairhope, Alabama 36532** on **Tuesday, June 11, 2019 until 10:00 A.M. Local Time**, for furnishing all labor and materials and performing all work for:

**Bid 028-19 for Project PW021-17**  
**TAPOA-TA17(937) New Sidewalk Between US 98 and CR 13 on CR 44 and Manley Road**

The work consists of the construction of a six (6) foot wide sidewalk along County Road 44 from Boothe Road to CR-13 and a five (5) foot wide sidewalk along Manley Road from US Highway 98 to Pemberton Loop.

A voluntary Pre-bid meeting will be held at Fairhope Public Works, 555 S. Section Street, Fairhope, Alabama on **Thursday, May 30<sup>th</sup> at 10:00 A.M. local time.**

Guarantee will be required with each bid as follows: A cashier's check or bid bond payable to **City of Fairhope, Alabama** in an amount not less than ten (10) percent of the amount of the bid, but in no event, more than \$10,000, must accompany the bidder's proposal. Performance and Payment Bonds and evidence of insurance required in the bid documents will be required at the signing of the Contract. Contract Bond (Performance Bond) will be required as follows: 100 percent of the Contract Price. Labor and Material Bond will be required as follows: 100 percent of the Contract Price.

All bidders bidding in amounts exceeding that established by the State Licensing Board for General Contractors must be licensed under the provisions of Title 34, Chapter 8, Code of Alabama, 1975, and must show evidence of license before bidding or bid will not be received or considered by the Engineer; the bidder shall show such evidence by clearly displaying his or her current license number on the outside of the sealed envelope in which the proposal is delivered. Out of state corporations shall furnish a certificate of authority to transact business in Alabama. Out of state limited liability companies shall provide proof of registration to transact business in this state.
