The City Council, City of Fairhope, met in regular session at 6:00 p.m., Fairhope Municipal Complex Council Chamber, 161 North Section Street, Fairhope, Alabama 36532, on Monday, 25 March 2019.

)( :

Present were Council President Jack Burrell, Councilmembers: Jay Robinson, Jimmy Conyers, Robert Brown, and Kevin Boone, Mayor Karin Wilson, City Attorney Marcus E. McDowell, and City Clerk Lisa A. Hanks.

There being a quorum present, Council President Burrell called the meeting to order. The invocation was given by Pastor John Martin with Celebration Church and the Pledge of Allegiance was recited.

Council President Burrell stated there was a need to add on an agenda item after Agenda Item Number 23: a resolution that Mayor Karin Wilson is hereby authorized to execute a Reimbursable Agreement for Relocation of Utility Facilities (Two Water Services) for County Project Number ERPR-8980(910) between the City of Fairhope and the Baldwin County Commission on CR9 for Bridge Replacement over Polecat Creek. The total estimated reimbursable cost is \$6,815.00.

Councilmember Conyers moved to add on the above-mentioned item not on the printed agenda. Seconded by Councilmember Boone, motion passed unanimously by voice vote.

Councilmember Brown moved to approve minutes of the 7 March 2019, regular meeting; minutes of the 7 March 2019, work session; and minutes of the 7 March 2019, agenda meeting. Seconded by Councilmember Conyers, motion passed unanimously by voice vote.

Mayor Wilson addressed the City Council and gave the following report:

We lost a great community leader March 8th. Bob Gentle was a self-made man who worked his way from the family hot dog stand, through Howard University to earn his degree in business, and eventually running a successful National Construction company.

He served as a City Councilman, was on multiple City committees and always engaged with all the happenings in Fairhope.

The last few sentences of his obituary were wonderful – he does have a few writers in his family! "We hold solace in the image of Bob pulling up a chair to God's table, and saying with a smile, "Well, what's going on with you today?" And God smiling back and saying, "Welcome home, Bob. Welcome home."

Council and I attended the annual National League of Cities earlier this month. One of the highlights of this trip for me was meeting with the director of the Center for Watershed Protection – a resource which works directly with state and local governments to assist with watershed and stormwater management needs.

As we start all RESTORE projects – namely the comprehensive land-use plan, this center will bring their expertise to address storm water design, codes & ordinances, and green infrastructure design & implementation.

We want to make sure we are using the most up-to-date applied research for responsible land development.

The City of Fairhope has been chosen to host the <u>National Oceanic and Atmospheric</u> <u>Administration's Gulf of Mexico Regional resilience conference</u> next week. The conference will attract elected officials, city planners, community leaders, and other decision-makers and experts from Texas, Louisiana, Mississippi, Alabama and Florida. During this conference academic professionals and experts will work with local decision-makers so that they can be better equipped to manage risks in their communities. Fairhope was chosen based on the extensive resiliency efforts implemented over the last two years.

Amy Chester was also invited with Rebuild by Design for a panel discussion. While she is here, she has agreed to facilitate the Community Engagement meeting we've scheduled for the K1 Center.

Which will be held on Wed, Apr 3rd from 9-Noon. The next meeting will be later in the day – we had to work with Amy's schedule and she's busy with the conference. The meeting will be the first in a series of actions that will include a survey for all voters.

You can pick up a press release regarding the community engagement meeting on the table in the back and citizens will be receiving a mailer as well.

Thank you to all our city employees who worked so diligently to help make this year's Arts & Crafts Festival such a success - Particularly the Public Works dept who put in long hours every day to ensure everything ran smoothly. Thanks to all the volunteers and the arts & crafts foundation as well.

The director round table meeting today included updates on some major projects currently underway in Public Works and Utilities. "Your tax-dollars at work"

We have completed more projects and working on more than ever in Fairhope. Disregarding deferred maintenance and long-term neglect for critical infrastructure upgrades, has been costing taxpayers greatly. But it is finally being addressed in a comprehensive way as part of an overall 5-year plan.

I encourage you to view the recorded meeting to catch up on all the progress.

The Rotary Pancake Breakfast was this past Saturday with a record-breaking number of attendees. The three Rotary Clubs in Fairhope take an active role in helping fund the enrichment programs at the Rotary Youth Club. I want to thank them and everyone at the club for making a difference in the lives of the children in the Fairhope community....

The city is so fortunate to have a resource like the Rotary Youth Club available for the young people of today and the future of tomorrow...these kids have so much potential...over 50% of the kids attending the Rotary Club are on AB honor roll.

I also shared the Rotary Youth Conceptual master plan for the outside property. During the South Fairhope outreach project completed last year, most in the community wanted to see this park updated and feel like a park which is open to the community. We've been working on what we'd like to achieve short-term and long- term

Mayor Wilson presented and read an Earth Day Proclamation to Hannah Pitman.

Councilmember Boone reminded everyone about the Fairhope Volunteer Fire Department's Smok'em if you Got'em, Saturday, March 30, 2019 from 2:00 p.m. to 10:00 p.m.

Council President Burrell thanked everyone for the Fairhope Arts and Crafts Festival: City staff and the Fairhope Arts and Crafts Festival Foundation.

Council President Burrell presented and read a Proclamation to the Robert Curtis Gentle family memorializing his passing on March 8, 2019.

A Public Hearing was held as advertised on a proposed ordinance to Amend Zoning Ordinance No. 1253. Councilmember Conyers introduced in writing an ordinance to zone the property of Fairhope Single Tax Corporation, Henry H. Brewster, Jr., and Barbara White Brewster, to R-2 Medium Density Single Family Residential District concurrent with annexation into the City of Fairhope. This property is generally located on the north side of Twin Beech Road between County Road 13 and Thompson Hall Road, Fairhope, Alabama. PPIN #77788. The property to be known as <u>Longbranch Subdivision</u>. The Planning Commission gave a favorable recommendation of this ordinance. Council President Burrell read the proposed ordinance.

Planning Director Wayne Dyess briefly explained the proposed ordinance; and said there are 18.71 acres. He also explained the "Future through Street" signs and the tree issue which will be taken care of during the final plat hearing.

Mayor Wilson left the dais at 6:35 p.m.

Council President Burrell opened the Public Hearing at 6:35 p.m. No one present opposed the proposed ordinance, the Public Hearing closed at 6:35 p.m.
