The City Council, City of Fairhope, met in regular session at 6:00 p.m., Fairhope Municipal Complex Council Chamber, 161 North Section Street, Fairhope, Alabama 36532, on Wednesday, 29 May 2019.

Present were Council President Jack Burrell, Councilmembers: Jay Robinson, Jimmy Conyers, Robert Brown, and Kevin Boone, Mayor Karin Wilson, City Attorney Marcus E. McDowell, and City Clerk Lisa A. Hanks.

There being a quorum present, Council President Burrell called the meeting to order. The invocation was given by Tim Clark, Worship Pastor of Celebration Church, and the Pledge of Allegiance was recited.

Council President Burrell stated there was a need to add on an agenda item (s) after Agenda Item Number 30: a resolution to Award Bid for Sewer Main Point Repair and By-Pass Connections for the Sewer Department (Bid Number 009-19) to W. R. Mitchell Contractor, Inc. with a total bid proposal of \$1,185,500.00. The first year of the contract will be \$250,000.00 with the remaining balance budgeted in the next two years.

Councilmember Boone moved to add on the above-mentioned item (s) not on the printed agenda. Seconded by Councilmember Brown, motion passed unanimously by voice vote.

Councilmember Conyers moved to approve minutes of the 10 May 2019, special called city council meeting; minutes of the 13 May 2019, regular meeting; minutes of the 13 May 2019, work session; and minutes of the 13 May 2019, agenda meeting. Seconded by Councilmember Brown, motion passed unanimously by voice vote.

Mayor Wilson addressed the City Council and gave the following report which is found at the end of the minutes.

Council President Burrell explained that the purchase of the Triangle property was \$8.75 million and appraised for \$12.0 million. He said we are crafting a conservation easement to protect the land. Council President Burrell said the land purchase was also recommended by the Recreation Board; and we are getting an appraisal for the land value. He commented the Twin Beech area parcel was 40 percent higher than appraisal. Mayor Wilson replied the property would be paid out of Impact Fee Funds.

The following individuals spoke during Public Participation for Agenda Items:

- 1) Mike Dudley, 19309 Scenic Highway 98, addressed the City Council regarding Agenda Item Number 28: a resolution that the City Council hereby authorizes Council President to execute a Conservation Easement Agreement between the City of Fairhope and Weeks Bay Foundation, Inc. for two conservation easements for the properties known collectively as the Dyas/Triangle property and to outline the terms of the easement transaction. He commented the amount was \$8.75 million plus attorneys' fees. He said Weeks Bay Foundation will manage, but what is the plan.
- 2) Jim Kellum, 3 Victorian Drive, addressed the City Council regarding Agenda Item Number 28: a resolution that the City Council hereby authorizes Council President to execute a Conservation Easement Agreement between the City of Fairhope and Weeks Bay Foundation, Inc. for two conservation easements for the properties known collectively as the Dyas/Triangle property and to outline the terms of the easement transaction. He stated it needs to be dedicated to public uses; and not commercially developed. Mr. Kellum said this is a great asset and could be a botanical park.
- 3) Ken Watson, Planning and Land Use Attorney, addressed the City Council regarding Agenda Item Number 28: a resolution that the City Council hereby authorizes Council President to execute a Conservation Easement Agreement between the City of Fairhope and Weeks Bay Foundation, Inc. for two conservation easements for the properties known collectively as the Dyas/Triangle property and to outline the terms of the easement transaction. He stated there may be legal issues and quoted Code of Alabama Section 11-47-20 which presents a challenge. Mr. Watson said we cannot pass a law that prevents another Council to do something in the future with land.
- 4) Debbie Quinn, Taylor Avenue, addressed the City Council regarding Agenda Item Number 29: Site Plan Review and Approval Request of Larry Smith, PE with S.E. Civil Engineering, on behalf of 10 N. Section, LLC (Matt Bowers), for approval of 10 N. Section Street Boutique Hotel, a Multiple Occupancy Project (MOP) with 13 units. She said 10 to 12 years ago the property was subdivided in two parts. The City negotiated the North part of the plaza. Ms. Quinn requested the City talk with Mr. Bowers to swap the parcels.
- 5) Corey Martin, 829 Summer Lake off Twin Beech, addressed the City Council regarding Agenda Item Number 26: a resolution that the City Council approves the selection of Equity Valuation Partners for Professional Appraisal Services to prepare an Appraisal on the property for City Parkland with a cost not to exceed \$5,000.00. Mr. Martin commented he was disappointed when he moved here. He said that square was a focal point of Fairhope; and families came from slavery and lived in the Twin Beech area. Mr. Martin said he cares about the children not adults. He told the City Council to do the right thing.
- 6) Barbara Davis, Battles Road, addressed the City Council regarding Agenda Item Number 26: a resolution that the City Council approves the selection of Equity Valuation Partners for Professional Appraisal Services to prepare an Appraisal on the property for City Parkland with a cost not to exceed \$5,000.00. She said kids need a park in the area; and there is more to this issue than dollars and cents.

- Ms. Davis commented the African Americans lack access to a park; and consider this investment as human capital.
- 7) Paul Ripp, 22985 High Ridge Road, addressed the City Council regarding Agenda Items Number 26 and Number 28. He said Number 26 is only politics; and soccer fields were purchased cheaper with a 22 foot grade. He commented Corte has a conservation easement across the street. Mr. Ripp said legally this will be stopped; and we are giving away property worth \$20.0 million dollars.
- 8) Ron Allen, 6612 Willow Bridge, addressed the City Council regarding Agenda Item Number 28: a resolution that the City Council hereby authorizes Council President to execute a Conservation Easement Agreement between the City of Fairhope and Weeks Bay Foundation, Inc. for two conservation easements for the properties known collectively as the Dyas/Triangle property and to outline the terms of the easement transaction. He said to hire someone to get a study like the University of South Alabama or Auburn University.
- 9) Diane Thomas, 23389 Main Street, addressed the City Council on Agenda Item Number 29: Site Plan Review and Approval Request of Larry Smith, PE with S.E. Civil Engineering, on behalf of 10 N. Section, LLC (Matt Bowers), for approval of 10 N. Section Street Boutique Hotel, a Multiple Occupancy Project (MOP) with 13 units. She said this is a shared community space; and the City's property will be enclosed with three sides. Ms. Thomas said she was not opposed to the hotel; and requested the City Council to table approval and negotiate a swap.
- 10) Operations Director Richard Peterson addressed the City Council on Agenda Item 28: a resolution that the City Council hereby authorizes Council President to execute a Conservation Easement Agreement between the City of Fairhope and Weeks Bay Foundation, Inc. for two conservation easements for the properties known collectively as the Dyas/Triangle property and to outline the terms of the easement transaction. He suggested changing the dynamics off of Fly Creek.
- 11) Special Projects Manager Lynn Maser and Mimi Tran (President of the Junior City Council) addressed the City Council regarding the new members of this Council. Ms. Tran said they are the youth's voice for Fairhope, part of State of the City, spoke with school children, took surveys at schools, prepared own social media and website, worked with Eastern Shore Chamber, will host a kickball tournament to benefit the Fairhope Rotary Club, and other events. Ms. Tran and Ms. Maser recognized the new members: Jack Marlow, Isabella McCormick, and Isabella Tran.
- 12) Stacy Wilson, 54 N. Church Street, addressed the City Council regarding Agenda Item Number 26: a resolution that the City Council approves the selection of Equity Valuation Partners for Professional Appraisal Services to prepare an Appraisal on the property for City Parkland with a cost not to exceed \$5,000.00. She commented when driving to and from the Lakewood Country Club you drive through a void of kudzu. Ms. Wilson commented the Mayor received a study and the City Council has disregarded. She said the parkland needs to go to the Twin Beech area.

Councilmember Robinson apologized to everyone regarding the bickering because this is a Professional Business Meeting. He gave specifics to some of the comments. He stated the City Council received the recommendations by Mayor Wilson and the study. The City Council gave unanimous consent to purchase the Twin Beech property; and it is not always about the money. Councilmember Robinson said we decided it would be most prudent to look for other property; and maybe the landowner will hear about this and we can negotiate for a lesser price. Councilmember Robinson said Corey Martin is a great person with kids; and he agrees with him in principal. On the Conservation Easement item, without legal authority "I will not move forward." Councilmember Robinson said he had numerous conversations with staff, and we do not need to rush with this item.

Councilmember Conyers reiterated what Councilmember Robinson said regarding the City Council being unanimous for purchasing the Twin Beech property. However, the appraisal received was 35 to 40 percent above the property value. He said we are doing the same process for this piece of property. Councilmember Conyers addressed Agenda Item Number 28; and gave an example of the 150 acres set aside in New York which is now Central Park. Councilmember Conyers said he is thinking about his kids and grandkids. He said we need to get public input for the property; and preserve it in perpetuity.

Conservation Easement and Parklands. He addressed Agenda Items Number 26, 28, and 29: two contractors looked at both parks and picked the one on the agenda; we need a Conservation Easement to preserve Fly Creek; and he hopes Mr. Bowers will consider a land swap.

Councilmember Boone reiterated what the Councilmembers had stated. We need to buy land for Parklands and plan for a Conservation Easement.

Council President Burrell agreed with the other Councilmembers. He said we had a Special Called Meeting for appointing the City Treasurer and addressed what the job description. Council President Burrell said he has not seen movement in offices or employees. He said our resolutions should be followed. Mayor Wilson replied no offices will be moved.

Mayor Wilson left the dais at 7:33 p.m.

A Public Hearing was held as advertised on a proposed ordinance to amend Zoning Ordinance No. 1253. Councilmember Robinson introduced in writing an ordinance to zone the property of The Teachers' Retirement Systems of Alabama to Tourist Resort (TR) concurrent with annexation into the City of Fairhope.

This property is generally located west of S. Section Street and the south side of Twin Beech Road, Fairhope, Alabama. PPIN Numbers: 5499, 20948, 286294, and 63314. The property to be known as <u>Colony at the Grand</u> with parcel containing 99.15 acres, more or less. The Planning Commission gave a favorable recommendation of this ordinance. Council President Burrell read the proposed ordinance.

Interim Planning Director Buford King briefly explained the proposed ordinance.

Mayor Wilson returned to the dais at 7:38 p.m.

Council President Burrell opened the Public Hearing at 7:38 p.m.

1) James Black, 18674 Twin Beech Road, addressed the City Council and said sewage is an issue; and the City concurs there is a problem. He said there needs to be more thought to this ordinance; and RSA has not attended any meetings. Mr. Black requested the City Council to hold adopting until issues have been resolved.

The Public Hearing closed at 7:41 p.m.

Councilmember Robinson questioned the sewer issues. Mr. King said there are infrastructure improvements in the subdivision.

Due to lack of a motion for immediate consideration, this ordinance will layover until the June 10, 2019 City Council meeting.

A Public Hearing was held as advertised on a proposed ordinance to amend Zoning Ordinance No. 1253. Councilmember Conyers introduced in writing an ordinance to amend Article III Zoning Districts, Section B. Allowed Uses, Table 3-1: Use Table be hereby amended to show Restaurants in the M-1 Light Industrial District and Section D. Special Conditions to include Restaurants and Accessory Bars in the M-1 Light Industrial District; and Article IX, Section C. Defined Terms to include the definition of Caterer. The Planning Commission gave a favorable recommendation of this ordinance. Council President Burrell read the proposed ordinance; and briefly explained that the Industrial Development Board reviewed this and recommended to allow restaurants and accessory bars in the Light Industrial District.

Planning Technician Mike Jeffries briefly explained the proposed ordinance.

Council President Burrell opened the Public Hearing at 7:49 p.m. No one present opposed the proposed ordinance, the Public Hearing closed at 7:49 p.m.

Due to lack of a motion for immediate consideration, this ordinance will layover until the June 10, 2019 City Council meeting.

A Public Hearing was held as advertised on a proposed ordinance to amend Zoning Ordinance No. 1253. Councilmember Conyers introduced in writing an ordinance to amend Article IX, Section C. Defined Terms to include the following revised and new definitions: Front Lot Line, Front Yard, Frontage Rear Yard, and Waterfront Lot. The Planning Commission gave a favorable recommendation of this ordinance. Council President Burrell read the proposed ordinance.

Planning Technician Mike Jeffries briefly explained the proposed ordinance.

Council President Burrell opened the Public Hearing at 7:51 p.m.

1) Diane Thomas, 23389 Main Street, addressed the City Council and asked what the ramifications for a waterfront property owner were.

Mr. Jeffries explained the specifications for a front yard on Mobile Bay and gave an example of where a storage building would be located. He also mentioned there was no definition for a waterfront lot and revising some of the other definitions.

The Public Hearing closed at 7:54 p.m.

Due to lack of a motion for immediate consideration, this ordinance will layover until the June 10, 2019 City Council meeting.

Councilmember Conyers moved for final adoption of Ordinance No. <u>1649</u>, an ordinance to amend Ordinance No. 1537 Known as the Sign Ordinance; Chapter 18.5 Signs; Section 18.5-3 Sign Permits and Exceptions; Specifically (b) (10) regarding Temporary Off-Site Directional Signs. (Introduced at the May 13, 2019 City Council Meeting) Seconded by Councilmember Brown, motion for final adoption passed by the following voice votes: AYE – Burrell, Robinson, Conyers, Brown, and Boone. NAY - None.

Councilmember Brown introduced in writing, and moved for the adoption of the following resolution, a resolution that City Council approves an additional Planner Position for the Planning Department; and amends the budget to fund this position. Seconded by Councilmember Conyers, motion passed by the following voice votes: AYE – Burrell, Robinson, Conyers, and Brown. NAY – Boone. Councilmember Boone commented all personnel job descriptions and positions should be brought before the Personnel Board.

Yael Girard, Executive Director of the Weeks Bay Foundation, addressed the City Council the Conservation Easement. She mentioned the NFWF grants that multiple municipalities are being required to put part of the property funded by the grants to be a Conservation Easement. Ms. Girard said no legal issues have come up yet; and our land trust has received the highest recognition for a land trust. She said the Weeks Bay Foundation is an advocate for Coastal Alabama. Ms. Girard stated there are no title transfers of property; and we do not have an easement with Arthur Corte. She said this is a contract to work with the City; and terms and conditions will be the landowner, stakeholders, and others. She said this will be a natural resource for the public.

Councilmember Robinson commented he still wants to table until we get a concrete legal answer. Council President Burrell agreed with Councilmember Robinson. City Attorney McDowell suggested getting an Attorney General Opinion; and get ideas before moving forward. Councilmember Conyers suggested cutting down the scope of work and had reservations to move forward and then table.

After further discussion, Councilmember Robinson moved to table Agenda Item Number 28: a resolution that the City Council hereby authorizes Council President to execute a Conservation Easement Agreement between the City of Fairhope and Weeks Bay Foundation, Inc. for two conservation easements for the properties known collectively as the Dyas/Triangle property and to outline the terms of the easement transaction.

The total cost of the conservation easement, due diligence, and closing fees for the property shall be \$39,025.00. Seconded by Councilmember Boone, motion passed by the following voice votes: AYE – Burrell, Robinson, Conyers, and Boone. NAY – Brown.

Interim Planning Director Buford King addressed the City Council to explain the Site Plan Review of property owned by 10 N. Section, LLC at the request of Larry Smith, PE with S.E. Civil Engineering, on behalf of 10 N. Section, LLC (Matt Bowers). Located at the located at the northeast corner of the intersection of Fairhope Avenue and Section Street in the Central Business District of downtown Fairhope, consisting of 0.07 acres, Fairhope, Alabama for a proposed 10 N. Section Street Boutique Hotel, a Multiple Occupancy Project (MOP) with 13 units; and approved contingent upon conditions recommended by the Planning Commission and Staff.

Councilmember Robinson commented it is a well written vision statement, but the hotel is not a benefit to that corner and obtrusive. He said no benefit to outweigh the public detriment. Councilmember Brown questioned the sidewalks. Mr. King replied it was for continuity. Council President Burrell stated we should push for eight feet on each side; and we would set the bar for a seven feet sidewalk exception.

Parking was questioned and Mr. King said that only home dwellings require onsite parking. Council President Burrell asked the developer if we could swap properties to keep our iconic downtown area. Clay Adams from Walcott Adams Verneuille Architects addressed the City Council on behalf of Matt Bowers. He said the plan is to incorporate the clock and build an historic looking building; and the courtyard will be developed too. Councilmember Brown said individually likes the hotel.

Mr. Bowers addressed the City Council and said he takes this seriously; and had a feasibility study prepared and a commercial realty company look at the site. Mr. Bowers commented he want to do a great project; and wants to be treated fairly. Councilmember Robinson said it looks good, but in the right place in Fairhope; and said he appreciated Mr. Bowers for being here. Councilmember Robinson said he has had 44 e-mails in the last 24 hours from citizens; and stated other factors hold me from voting on it right now.

Mayor Wilson said this is a consistent process and he has worked with staff. Council President Burrell said he met with Mr. Bowers and I did walk away. He said I am just one out of five and cannot decide on my own. Councilmember Boone commented that he has developed many properties and always found his problems and addressed before moving forward. He said, "I would never develop on that corner." Councilmember Brown said Mr. Bowers was open for a swap and he did not reach out.

Councilmember Robinson moved to table the Site Plan property owned by 10 N. Section, LLC (Matt Bowers) listed above for future research. The motion was seconded by Councilmember Boone.

Mayor Wilson commented Mr. Bowers went through the process. Councilmember Robinson replied, Mayor you did not do that with the Fly Creek apartments. After further discussion, motion passed by the following voice votes: AYE – Burrell, Robinson, Conyers, and Boone. NAY – Brown.

Councilmember Boone moved to appoint Jake O'Neil to replace Ron Hayes to the Personnel Board for a 5-year term which will expire December 2023 and to appoint John Manelos to the Personnel Board for a 5-year term which will expire December 2024. Seconded by Councilmember Brown, motion passed unanimously by voice vote. Diane Thomas, Chair of the Personnel Board, introduced John Manelos as one of the newest members. Mr. Manelos stated it was a privilege and honor to serve on this Board; and said the City is great because of the great City employees.
