Sealed proposals will be received by the City of Fairhope of Baldwin County, Alabama, in the City of Fairhope, 555 South Section Street, Fairhope, Alabama 36532 until 10:00 A.M. July 23, 2019 and then publicly opened thereafter, for furnishing all labor and materials, and performing all work required by the City of Fairhope and described as follows:

**BID NUMBER 018-19 Bayou Dr., Fairway Blvd, and Fairhope Av Transmission System--Part #2**  
**PROJECT NO. SEW002-18 Wastewater Collection and Transmission System Improvements**

*The project will consist of installing approximately 5300 linear, in multiple segments, 24" HDPE DR 11 (or 18" Fusible PVC) to be directionally bored along Fairhope Ave, Fairwood Drive, and Bayou Drive, where it will terminate at Section Street into a new gravity sewer main. The proposed gravity sewer will consist of approximately 1400 linear feet of 24" C-900 DR 18 sewer pipe, with several manholes. One section will be pile supported for approximately 200 linear feet. Connections will be required within the Fairhope Water Reclamation Facility requiring a by-passing operation of approximately 3 million gallons per day for a period of time necessary to perform work within the plant. This work will be will also provide an alternative for direct bury of sewer force main listed above.*

Copies of the plans and specifications will be available for purchase at Dewberry Engineers, Inc, 25353 Friendship Road, Daphne, AL 36526, at a nonrefundable charge of \$100 per set. Please make checks payable to Dewberry. No plans and specifications will be issued to contractors later than one (1) week prior to the time indicated above for receiving bids.

Seventy-Two (72) hours prior to the bid opening or will be forever waived.

All bids must be on the bid forms provided in the Bid Documents. Bids shall be accompanied by a Bid Security equal to 5% (percent) of the bid price, but in no event more than \$10,000.00. Bid Security shall be in the form of a Bid Bond or a cashier's check payable to The City of Fairhope. No Bid Security is required on bids less than \$10,000.00.

**THERE WILL BE A MANDATORY PRE-BID MEETING AT 10:00AM, July 16, 2019 at the City of Fairhope Offices at 555 Section Street, Fairhope, AL 36532.**

The City of Fairhope is an Equal Opportunity Employer and requires that all contractors comply with the Equal Employment Opportunity laws and the provisions of the Contract Documents in this regard. The City also encourages and supports the utilization of Minority Business Enterprises on this and all public bids.

All bids, with their guarantee (when required), must be enclosed in a sealed, opaque envelope, clearly identified on the outside as a **"Sealed Bid" with Item Name, Bid Number, City of Fairhope's Name and Address, Bidder's Name and Address, and Bidder's State of Alabama Contractor's License Number.** Each bid must be in a separate envelope. Bids made out in pencil will not be accepted.

Failure to observe the instructions contained herein will constitute grounds for rejection of your bid. The City reserves the right to accept or reject any or all bids or for any reason that is in the best interest of the City of Fairhope.

The company that is awarded the bid must have Workman's Compensation Insurance on all of its employees if work is done on City premises. General Liability Insurance must be maintained to hold the City harmless in the event of an accident. The City of Fairhope will require proof of Workman's Compensation Insurance if work is done on City premises and General Liability Insurance specifying coverage must accompany this bid packet. See contract documents for details.

No bids will be considered unless the CONTRACTOR, whether resident or non-resident of Alabama, is properly qualified to submit a proposal for this type of work in accordance with all applicable laws of the State of Alabama. Where applicable, this shall include evidence of holding a current license from the State Licensing board for General Contractors, Montgomery, Alabama, as required by Chapter 8 of Title 34, of the Code of Alabama, 1975. In addition, the awarded vendor, if non-resident of the State, and if a corporation, shall show evidence of having qualified with the Secretary of State to do business in the State of <http://sos.alabama.gov/business-entities>. CONTRACTOR must have a current business license or purchase a business license with the City of Fairhope prior to work performed. Contractor currently or within the past 5 years involved in litigation with a municipality or utility company shall disclose that information with their bid proposal, this information may have bearing on bid award. Details related to current or previous litigation may be grounds for debarment. No bids shall be withdrawn for the period of thirty (30) days subsequent to the opening of proposals without the consent of the City of Fairhope, Baldwin County, Alabama.
