The grant is being submitted as an 80/20 match with an estimated project cost of \$997,915.63: Grant will fund \$798,332.50 and the City will provide \$199,583.13 plus Engineering Design Fees estimated to be \$937,313.00 and Utility Relocates estimated to be \$50,000.00.
- 16. Resolution That the City of Fairhope hereby terminates Contract Extension No. 2 titled <u>Tree Trimming Services 2017</u>, between the City of Fairhope and Burford's Tree, Inc., due to failure to perform to the standards of the Contract (Default); and notice has been given.
- 17. Resolution That the Governing Body of the City of Fairhope, Alabama, hereby rejects Bid Number 030-19 for Fairhope Docks Bulkhead Improvement Project for the Public Works Department; and authorizes the City to negotiate a contract with the one bidder, pursuant to the Code of Alabama 1975, Section 39-2-6(b).
- 18. Resolution To Award Bid for Bayou Drive, Fairway Boulevard, and Fairhope Avenue Transmission System Part 2 for the Sewer Department (Bid Number 018-19) to Boan Contracting Co. with a total bid proposal of \$2,149,421.08.
