The City Council, City of Fairhope, met in regular session at 6:00 p.m., Fairhope Municipal Complex Council Chamber, 161 North Section Street, Fairhope, Alabama 36532, on Wednesday, 9 October 2019.

Present were Council President Jack Burrell, Councilmembers: Jay Robinson, Jimmy Conyers, Robert Brown, and Kevin Boone, Mayor Karin Wilson, City Attorney Marcus E. McDowell, and City Clerk Lisa A. Hanks.

There being a quorum present, Council President Burrell called the meeting to order. The invocation was given by Pastor Rick Malugani of Fairhope Christian Church and the Pledge of Allegiance was recited.

Council President Burrell stated there was a need to add on an agenda item after Agenda Item Number 16: a resolution That the date for the 2019 Annual Magical Christmas Parade shall be set on Friday night December 6, 2019. The Annual Parade shall start at approximately 7:00 p.m. on said date and notice of said date change shall be communicated to all prospective and actual applicants. Additionally, Fairhope's monthly traditional First Friday Art Walk shall be moved once to Saturday, December 7, 2019.

Councilmember Boone moved to add on the above-mentioned item not on the printed agenda. Seconded by Councilmember Brown, motion passed unanimously by voice vote.

Councilmember Conyers moved to approve minutes of the 11 September 2019 special budget work session, minute of the 23 September 2019, regular meeting; minutes of the 23 September 2019, work session; minutes of the 23 September 2019, agenda meeting; and minutes of the 30 September 2019 special budget work session. Seconded by Councilmember Robinson, motion passed unanimously by voice vote.

Mayor Wilson addressed the City Council regarding the budget; Mayor's Institute on Design; Leadership Baldwin County; and the new Junior City Council for this year. After the introduction of each new member and photo was taken with the Mayor with the City Council and City Clerk behind them.

RESOLUTION NO. 3521-19

AUTHORIZING AND CONSENTING TO THE TRANSFER OF OWNERSHIP, MAINTENANCE, AND RESPONSIBILITY FOR PORTIONS OF TWIN BEECH ROAD (AKA CR44) AND BISHOP ROAD IN THE CITY OF FAIRHOPE

WHEREAS, Twin Beech Road (also known as CR44) from the intersection of Greeno Road (US Hwy 98) to the intersection of County Road 13 approximately 5,280 feet in length (1.0 mile); and Bishop Road from the intersection of Fairhope Avenue to the intersection of Edwards Avenue approximately 1,320 feet in length (0.25 mile), are roads or road segments with the majority of the road frontages inside the corporate limits of the City of Fairhope and collectively described herein as "the Fairhope Roads"; and

WHEREAS, the City of Fairhope desires to take over sole and exclusive ownership, control, management, supervision, regulation, repair, maintenance, improvement, and responsibility for the Fairhope Roads in order to facilitate the orderly development and maintenance of this area in its corporate limits; and

WHEREAS, the City of Fairhope has found and determined that taking over sole and exclusive ownership, control, management, supervision, regulation, repair, maintenance, improvement, and responsibility for the Fairhope Roads is in the best interest of the City of Fairhope; and

WHEREAS, the City of Fairhope has the legal authority to carry out the intent of this resolution pursuant to <u>Code of Alabama</u>, Section 11-49-80 and other state laws and constitutional amendments.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Fairhope, Alabama, as follows:

Section 1. That the City of Fairhope hereby agrees to accept and take over from Baldwin County the sole and exclusive ownership, control, management, supervision, regulation, repair, maintenance, improvement, and responsibility for the Fairhope Roads.

Section 2. That the Mayor, City Clerk, and other City officials are hereby authorized to execute and deliver such documents or agreements to Baldwin County as are necessary or requested to carry out the intent of this Resolution.

Section 3. Based on the condition and use of that portion of the Fairhope Roads, in accordance with <u>Ala. Code</u> Section 11-49-80 and 81 (1975), the County and the City of Fairhope agree that the County shall not be required to pay any sum or sums for being relieved of the burden of the ownership, control, management, supervision, repair, maintenance and improvement of the Fairhope Roads.

Section 4. If any part, section or subdivision of this Resolution shall be held to be illegal, invalid or unenforceable for any reason, such holding shall not be held or construed to invalidate or impair the remaining provisions of this Resolution which shall continue in full force and effect notwithstanding such holding.

The following individual spoke during Public Participation for Non-Agenda Items:
