 Request to rezone the property of the Anil K. Vira and Pallavi Vira from R-2 Medium Single Family Residential District to B-1 Local Shopping District. The property is generally located at 303 Fels Avenue, Fairhope, Alabama. PPIN Number: 37258.
- 6. **Final Adoption -** Ordinance Amend Zoning Ordinance No. 1253.

 Request to rezone the property of the Fairhope Single Tax Corporation and Pauline J. Moyd from RA Residential/Agriculture District to Planned Unit Development (PUD). The property is generally located at the southwest corner of the intersection of Bay Meadows Avenue and State Highway 181, Fairhope, Alabama; known as Live Oaks Estates PUD. PPIN Number: 15078; parcel containing 37.961 acres, more or less.

Resolution That the City Council approves the selection of Paul Davis Architecture, PC to provide Professional Architecture Services for ADA Compliance at the Fairhope Stadium Property (RFQ No. PS002-20); and hereby authorizes Mayor Karin Wilson to execute a Contract with a not to exceed \$12,000.00.

Resolution That the City Council approves the selection of Lieb Engineering Company, LLC to provide Professional Engineering Services for ADA Compliance at the Fairhope Stadium Property (RFQ No. PS004-20); and hereby authorizes Mayor Karin Wilson to execute a Contract with a not to exceed \$14,000.00.

Resolution To Award Bid Number 041-19 for Improvement to Four (4) Electric Substations for Project EL006-19 for the Capital Improvement Plan to Upgrade Substations at Twin Beech, Nichols, Morphy, and Volanta for the Electric Department to Aubrey Silvey Enterprises, Inc., with a total bid proposal of \$4,950,000.00.
- 16. Resolution To Award Bid Number 004-20 for Fiber Optics Internet Services (3-Year Agreement) for the IT Department to Harbor Communications, LLC, with a total bid proposal of \$10,800.00 per year; and (Total not to exceed of \$32,400.00 for the 3-Year Agreement).
- 17. Resolution To Award Bid Number 002-20 for VoIP Platform (Voice over IP) for the IT Department to Harbor Communications, LLC, with a total bid proposal of \$43,080.00.
- 18. Resolution That Mayor Karin Wilson is hereby authorized to execute Change Order No. 1 to Bid Number 033-19, Erosion Control and Stabilization of Rock Creek for an additional 2.5' thick class 3 riprap lining with a brush mattress underlayment in the pool just downstream from the Rock Creek Bridge. This addition to the Erosion Control and Stabilization of Rock Creek was due to unforeseen weather conditions of extreme heat and drought in late spring and extreme rainfall associated with TS/Hurricane Barry in mid-July 2019 which increased the cost in an amount not-to-exceed \$24,000.00; and award of the Change Order to Streamline Environmental, LLC.
- 19. Resolution That Mayor Karin Wilson is hereby authorized to execute Change Order No. 1 to Bid Number 040-19, Well Abandonment Services for additional work to install 75 more feet of grout and 10 feet of holeplug in the 16 inch diameter hole which added an additional day to project. This addition to the Well Abandonment Services was due to some sort of void in the wall casing which increased the cost in the amount of \$6,000.00; and award of the Change Order to M & W Drilling, LLC.

- 20. Resolution That the City Council authorizes Mayor Karin Wilson to temporarily fill the position of Special Events Coordinator at a pay grade of 20 with a salary not to exceed the minimum of that grade; and to allow the temporary employee to work up to 40 hours per each week which does not include benefits as long as the employee does not work over the 90 days or until Special Events Coordinator returns to work plus seven (7) working days.
- 21. Resolution That the City Council authorizes and approves the hiring of the new Customer Service Rep 1 to allow the current Customer Service Rep 1 to train the new employee prior to her leaving the first of January 2020. This will be beneficial to the City as well as the new hire.
