- 2.11.1 Forms furnished, or copies thereof, shall be used, and strict compliance with the requirements of the Invitation, these instructions, and the instructions printed on the forms is necessary. Special care should be exercised in the preparation of Quotes. Bidders must make their own estimates of the facilities and difficulties attending the performance of the proposed contract, including local conditions, uncertainty of weather, and all other contingencies. All designations and prices shall be fully and clearly set forth. The proper space in the Quote forms shall be suitable filled in.
- 2.11.2 Fill in all blanks on the Quote Form with non-erasable ink or type. Erasers or other changes must be explained or noted over the signature of the Quoter.
- 2.11.3 The Quote Form <u>may</u> have a Contingency Allowance listed. Add this amount to the Quote Base to derive the Total Quote. - 2.11.4 Each Quote must give the full business address of the bidder and must be signed by him with his usual signature. Combination Quotes, that is, Quotes on separate projects lumped together as a single Quote or on all or none basis, will not be accepted unless the contract document expressly requests or permits same. Alternate Quotes will not be considered unless requested. Bidders are to provide with their Quote, a reference list to include name/address/phone number.

2.12 QUOTE INELIGIBILITY Quotes that contain irregularities of any kind may be declared unacceptable at the discretion of the Owner. The Owner may waive any minor irregularities and may reject any or all Quotes. Quotes received after the deadline will be returned to the bidder unopened.

2.13 CONTRACT TIME

The CONTRACTOR agrees to perform the work within the time stated in the Quotation Response Form. The bidder in submitting an offer accepts the conditions of the contract period stated for performing the work.

2.14 CONSTRUCTION DOCUMENT IDENTIFICATION

The Construction documents are the Quote Packet, Drawings, Addenda, and all other related documents bearing the Project Title and Number. Bidders shall use complete sets of Construction

Documents in preparing their Bids. The City will not assume responsibility for errors or misinterpretation resulting from the use of incomplete sets of Construction Documents.

2.15 INQUIRIES/ADDENDA Questions or comments pertaining to this Quote must be presented in writing, sent as <u>e-mail</u> to the attention of the Purchasing Manager, Dee Dee Brandt at <u>DeeDee.Brandt@fairhopeal.gov</u>, Seventy-Two (72) hours prior to the Quote opening or will be forever waived.

2.15.1 All Addenda are part of the Contract Documents. Include resultant costs in the Quote. Addenda will be issued by posting to the City of Fairhope website,www.fairhopeal.gov and posted on the City's bulletin board at 555 South Section St., Fairhope, AL. It is the responsibility of the bidder to obtain any addenda and verify that all addenda have been received.

2.16 QUOTE ACCEPTANCE

Quote with lowest Total Quote amount from a responsive and responsible bidder may be accepted if within the contract budget. If alternates are listed on the Quote Form, the lowest combination of Total Quote and Alternate Quotes accepted by the owner shall be the accepted Quote. Alternates shall be awarded in the order in which they are listed on the Quote Form.

2.17 BIDDERS INTERESTED IN MORE THAN ONE QUOTE

If more than one Quote is offered by any one party, by or in a name of his clerk, partner, corporation in which he has a substantial interest, or in which he is an officer, or other person, all such Quotes may be rejected. A party who has quoted prices on materials to a Quote is not thereby disqualified from quoting prices to other bidders or from submitting a Quote directly for the materials or work. The City reserves the right to determine in its discretion whether the provisions of this clause have been violated by any bidder.

2.18 ERRORS IN QUOTES

Bidders or their authorized agents are expected to examine the maps, drawings, specifications, and all other instructions pertaining to the work, which will be open to their inspection. Failure to do so will be at the bidder's own risk. In case of error, in the extension of prices the unit price will govern.

2.19 CONTRACT AND BOND

The bidder to whom award is made must, when requested, enter into written contract on the standard form as set out herein, with satisfactory security in the amount required, within the period specified, or, if no period be specified, within 15 days after the required forms are presented for signature.

2.20 COLLUSION

If there is any reason for believing that collusion exists among the Bidders, any or all Quotes may be rejected, and those participating in such collusion may be barred from submitting Quotes on the same or other work with the City.

2.21 SUBLETTING OR ASSIGNING OF CONTRACT

Limitations: The CONTRACTOR shall not sublet, assign, transfer, convey, sell or otherwise dispose of any portions of the contract, his right, title, or interest therein, or his power to execute such contact, to any person, firm or corporation without written consent of the City, and such written consent shall not be construed to relieve the CONTRACTOR of any responsibility for the fulfillment of the contract. Unless otherwise stipulated in the proposal or special provisions, the

CONTRACTOR shall perform with his own organization, and with the assistance of workmen under his immediate superintendence and reported on his payroll, all contract work of a value not less than 50 percent of the total contract amount, except that any items designated in the contract as "Specialty Items" so performed by sub-contract may be deducted from the total contract amount before computing the amount of work required to be performed by the CONTRACTOR with his own organization.

2.21.1 SUB-CONTRACTOR'S Status: A SUB-CONTRACTOR shall be recognized only in the capacity of an employee or agent of the CONTRACTOR and the CONTRACTOR will be responsible to the City for all of the Sub-CONTRACTOR'S work, including failures or omissions; and his removal may be required by the Project Manager, as in the case of an employee.

2.22 PROSECUTION OF WORK The CONTRACTOR shall commence work as otherwise directed in writing per specifications.

- 2.22.1 The CONTRACTOR shall prosecute the work continuously and diligently in the order and manner set out in his schedule as approved by the City. He shall provide sufficient satisfactory materials, labor, and equipment to ensure that the work will be completed in a satisfactory manner within the time specified in the contract.
- 2.22.2 Should the CONTRACTOR fail to maintain a satisfactory rate of progress, the City may require that additional forces and/or equipment be placed on the work to bring the project up to schedule and maintain it at that level.
- 2.22.3 Should the Contract fail to furnish sufficient satisfactory equipment and/or labor for maintaining the quality and progress of the work at satisfactory level, the City may withhold all estimates that may become due until satisfactory quality and progress are maintained; or the contract may be annulled.

EXCEPTIONS / CHANGES

1. Compliance with or variations from the specifications must be noted as to each item on the Specification Sheet. This requirement must be met even though the Purchasing Manager may alter the specifications in the form of an addendum to accommodate variances. A request for a change in the specifications to accommodate a variation must be called to the attention of the Purchasing department at least 72 hours before the Quote opening date. All requests for such changes will be considered and the merits weighed. Only those changes in specifications deemed to be in the best interest of the City will be made. In the event of a change in specifications, an addendum will be supplied to bidders. Exceptions may be accepted if they are minor, equal, or superior to that which is specified, and provided that they are listed and fully explained on a separate page entitled, "Exceptions to Specifications". The exceptions shall refer to the specification page and paragraph number The City shall determine which (if any) exceptions are acceptable and this determination shall be final.

4.0 INSURANCE REQUIREMENTS

4.03

Awarded Contractor, at its sole expense, shall obtain and maintain in full force the following insurance to protect the Contractor and the City of Fairhope at limits and coverages specified herein. <u>The City of</u> <u>Fairhope will be listed as an additional insured under the Contractor's General Liability insurance and</u> <u>automobile liability insurance policies, and all other applicable policies and certificates of insurance</u>. These limits and coverages specified are the minimum to be maintained and are not intended to represent the correct insurance needed to fully and adequately protect the awarded Bidder.

4.01 <u>All insurance</u> will be provided by insurers by admitted carriers in the State of Alabama, shall have a minimum A.M. Best rating of A-VII and must be acceptable to the CITY. Self-insured plans and/or group funds not having an A.M. Best rating must be submitted to the CITY for prior approval.

4.02 NO WORK IS TO BE PERFORMED UNTIL PROOF OF COMPLIANCE WITH THE INSURANCE REQUIREMENTS HAS BEEN RECEIVED BY THE CITY.

5.01.1 The City of Fairhope is requesting responses to repair and replace the composite asphalt shingle roof on the Former USA Building located at 10 North Summit Street, Fairhope, Alabama. During Hurricane Sally, September 16, 2020, hipped and gabled roof system was damaged beyond repair. The respondent shall submit a lump sum price to completely repair and replace the roof to current code standards. The lump sum price should include all material, equipment, tools, labor, and incidentals to deliver a complete "turnkey" replaced roof system.

GENERAL SPECIFICATIONS

 - Remove Existing Shingles and Felt to Decking
 - Inspect, Remove and Replace any Bad Decking as needed

1. ACCEPTANCE OF AGREEMENT

This Agreement contains all terms and conditions agreed upon by the OWNER and Winning bidder. No other agreement, oral or otherwise, regarding the subject matter of this Agreement shall be deemed to exist or to bind either party hereto. The Winning Bidder shall not employ Subcontractors without the express written permission of the OWNER. No waiver, alteration, consent or modification of any of the provisions of the Agreement shall be binding unless in writing and signed by the OWNER and CONTRACTOR. This Agreement shall not be construed against the party or parties preparing it. It shall be construed as if all the parties and each of them jointly prepared this Agreement, and any uncertainty or ambiguity shall not be interpreted against one or more parties.

2. ACCEPTANCE OF WORK

The City of Fairhope will be deemed to have accepted the Work after the City of Fairhope agrees the Work is completed by signature on delivery or service tickets. In the event Work furnished under the Contract / Agreement / Purchase Order is found to be defective or does not conform to the intent of the Contract / Agreement / Purchase Order, the awarded vendor shall, after receipt of notice from the City of Fairhope, correct the deficiencies. Failure on the part of the awarded vendor to properly correct the deficiencies within the time period allowed will constitute the City of Fairhope's right to cancel the Contract / Agreement / Purchase Order immediately, upon written notice to the awarded vendor.

3. ADDENDA

25. INDEMNITY

37. NON-EXCLUSIVE

Unless otherwise specified, this Contract / Agreement / Purchase Order is considered a non-exclusive Contract /Agreement /

Purchase Order between the parties.

38. NOTIFICATION AND ACCIDENT REPORTS

In the event of accidents of any kind, in the performance of a Contract / Agreement / Purchase Order, the awarded vendor shall notify the City of Fairhope immediately and furnish, without delay, copies of all such accident reports to the City of Fairhope. 48. REJECTION OF BIDS

The City of Fairhope reserves the right to reject at destination and hold at the vendor's risk and expense any goods supplied by the vendor which do not conform to the specification or description embodied in the order or are inferior in any respect to the good specified. Any good bought by sample which is inferior in quality to the sample submitted by vendor will be rejected. Any goods delivered that do not meet specifications may be returned to the vendor at its expense. When a good is returned, the vendor must make immediate replacement with acceptable merchandise or the City of Fairhope may seek remedies for default.

56. TABULATION

Bid results are posted on The City of Fairhope's web site: <u>www.fairhopeal.gov</u>. The awarded vendor will be sent a written notification via mail.

57. TAXES

Prices quoted shall be delivered prices, exclusive of all federal or state excise, sales, and manufacturer's taxes. The City will assume no transportation or handling charges other than specified in the RFQ, ITB, RFP or other form of solicitation. The City is tax exempt by law – Code of Alabama 1975.

58. TERMINATION FOR CONVENIENCE

Any Contract / Agreement / Purchase Order may be terminated for convenience by the City of Fairhope, in whole or in part, by written notification to the awarded vendor.

59. TERMINATION FOR DEFAULT

Performance of Work under the Contract / Agreement / Purchase Order Agreement may be terminated by the City of Fairhope, in whole or in part, in writing, whenever the City of Fairhope determines that the awarded vendor has failed to meet the requirements of the Contract / Agreement / Purchase Order.

60. TERMINATION FOR NON-APPROPRIATION Termination

for Non-appropriation – The continuation of any financial

obligation beyond the current fiscal year is subject to and contingent upon sufficient funds being appropriated, budgeted, and otherwise made available by the local source, State Legislature and/or federal sources. The City of Fairhopemay terminate any financial obligation, and awarded vendor waives any and all claim(s) for damages, effective immediately upon receipt of written notice (or any date specified therein) if for any reason the City of Fairhope's funding from local, State and/or federal sources is not appropriated, withdrawn or limited.

61. TIME IS OF THE ESSENCE

The City of Fairhope and awarded vendor agree that time is of the essence in the performance of work called for under this Contract / Agreement / Purchase Order. The awarded vendor agrees that all work will be accomplished regularly, diligently and uninterrupted at such a rate of progress as will ensure full completion thereof within reasonable time periods.

62. TITLE

All titles, fees, as well as other charges, are to be paid by awarded vendor. Awarded vendor is to furnish prepaid certificate of title in the name of the City of Fairhope, Title shall change upon acceptance of delivery at the City of Fairhope approved delivery location.

63. VENDOR LIST

A vendor may be removed from the City of Fairhope's Bidders List if a vendor fails to respond to three (3) consecutive ITB's. A properly submitted "No Bid" is considered as a response and the vendor will receive credit for the response.

64. WARRANTY

The awarded vendor expressly warrants that all articles, materials, and work offered shall conform to each and every specification, drawing, sample, or other description which is furnished to or adopted by the City of Fairhope, and that it will be fit and sufficient for the purpose intended, merchantable, of good material and workmanship, and free from defects. The awarded vendor further warrants all items for a period of one year, unless otherwise stated, from the date of acceptance of the items delivered and installed or work completed. All repairs, replacements, or adjustments during the warranty period will be at the awarded vendor's sole expense. Awarded vendor will provide written warranty for all parts and labor for a period of (1) one year commencing from date of written acceptance of delivery by City of Fairhope. Awarded vendor will provide written copies of all other applicable warranties, such as, Manufacturer's

warranty. Those warranties, if any, will be in addition to the awarded vendor's warranty, and the terms of which will not be altered by the awarded vendor's warranty.

65. IMMIGRATION LAW

The CONTRACTOR agrees that it shall comply with all of the requirements of the **Beason-Hammon Alabama Taxpayer and Citizen Protection Act, Act No 2011-535**, Alabama Code (1975) Section 31-13-1, et. Seq., (also known as the Alabama Immigration Act) see Section 31-13-9, and the provisions of said Act, including all penalties for violation thereof, are incorporated herein.

The contract consists of all of the items contained within this contract, the quotation package, proposal, scope of work, specifications and if any drawings addenda, amendments, and "City of Fairhope Standard Terms and Conditions", which are attached hereto and made a part hereof, as if fully contained herein; for the performance of all work and the furnishing of all labor and materials required.
- 2 The **CONTRACTOR** shall perform all the **WORK** described herein.
- 3. The **WORK** to be performed under this **CONTRACT** shall be commenced upon execution of this **CONTRACT** within number TEN (10) days of the date specified in the *Notice to Proceed* (NIP) to be issued to the **CONTRACTOR** by the **OWNER**, or its authorized representative. The work shall be completed, subject to authorized adjustments, within SIXTY (60) consecutive calendar days from and after the commencement date stipulated in said *Notice to Proceed*. Liquidated damages for non-completion of the work within this time limit will be assessed at the rate of \$200 per working day.
- 4. The OWNER shall pay the CONTRACTOR in current funds for the performance of the WORK, the CONTRACT SUM of ______DOLLARS (\$ _____). This represents a LUMP SUM payment for performance of the WORK, which payment shall be issued after the Contract is fully performed and the OWNER has inspected the WORK.

3.0 GENERAL CONDITIONS

- 3.01 **Indemnity:** The **CONTRACTOR** hereby agrees to indemnify and save harmless the **OWNER**, its officers, agent, and employees, from and against any and all liabilities, claims, demands, damages, fines, fees, expenses, penalties, suits, proceedings, actions and cost of actions, including reasonable attorneys' fees for trial and on appeal, of any kind and nature, arising or growing out of, or in any way connected with the performance of this Contract, to the extent caused by a negligent act or omission of the **CONTRACTOR**, their agents, servants, employees,
- 3.02 Notification and Accident Reports: In the event of accidents of any kind, the CONTRACTOR shall notify the OWNER immediately and furnish, without delay, copies of all such accident reports to the OWNER. If in the performance of their Work, the CONTRACTOR fails to immediately report an accident to the OWNER, of which the CONTRACTOR has knowledge of and which results in a fine levied against the OWNER then the CONTRACTOR shall be responsible for all fines levied against the OWNER.

4.0 <u>Termination of Agreement</u>

4.01 **Termination for Default:** Performance of Work under this Agreement may be terminated by the **OWNER**, in whole or in part, in writing, whenever the **OWNER** determines that the **CONTRACTOR** has failed to meet the requirements of this Agreement.

- 4.02 **Termination for Convenience:** In the event that any of the provisions of this contract are violated by the CONTRACTOR, or by any of his subCONTRACTORs, the OWNER may serve written notice upon the CONTRACTOR and the surety of his intention to terminate the contract, such notices to contain the reasons for such intention to terminate the contract, and unless within 10-days after the serving of such notice upon the CONTRACTOR, such violation or delay shall cease and satisfactory arrangement of correction be made, the CONTRACTOR shall, upon the expiration of said 10-days, cease and terminate. In the event of any such termination, the OWNER shall immediately serve notice thereof upon the surety and the CONTRACTOR and the surety shall have the right to take over and perform the contract; provided, however, that if the surety does not commence performance thereof within 30-days from the date of the mailing to such surety of notice of termination, the OWNER may take over the work and prosecute the same to completion by contract or by force account for the account and at the expense of the CONTRACTOR and the CONTRACTOR and his surety shall be liable to OWNER for any excess cost occasioned the OWNER thereby, and in such event, the OWNER may take possession of and utilize in completing the work, such materials, appliances and plant as may be on the site for the work and necessary therefore.
- 4.03 Termination for Cause: The State and OWNER may terminate the Contract at any time without penalty by giving 30-days written notice to the CONTRACTOR of such termination or negotiating with the CONTRACTOR an effective date. CONTRACTOR shall be entitled to payment for deliverables in progress, to the extent work has been performed satisfactorily.

- 6.04 This Contract contains all terms and conditions agreed upon by the **OWNER** and **CONTRACTOR**. No other agreement, oral or otherwise, regarding the subject matter of this Contract shall be deemed to exist or to bind either party hereto.
- 6.05 This Contract shall not be construed against the party or parties preparing it. It shall be construed as if all the parties and each of them jointly prepared this Contract, and any uncertainty or ambiguity shall not be interpreted against one or more parties.
- 6.06 A prospective contractor that is listed on the government-wide Excluded Parties List System in the System for Award Management (<u>www.SAM.gov</u>) as suspended or debarred, **CANNOT** be awarded a contract funded with Federal assistance.

1.0 Background

The Beason-Hammon Alabama Taxpayer and Citizen Protection Act, Act No 2011-535, as amended by Act No 2012-491, Code of Alabama (1975) Section 31-13-1 through Section 31-13-30 (also known as and hereinafter referred to as "the Alabama Immigration Act") is applicable to contracts with the City of Fairhope, Alabama. All business entities entering into contracts with the City of Fairhope, Alabama will comply with the Alabama Immigration Act.

2.0 Definitions

ALIEN. Any person who is not a citizen or national of the United States, as described in 8 U.S.C. § 1101, et seq., and any amendments thereto.

BUSINESS ENTITY. Any person or group of persons employing one or more persons performing or engaging in any activity, enterprise, profession, or occupation for gain, benefit, advantage, or livelihood, whether for profit or not for profit. Business entity shall include but not be limited to the following:

- a. Self-employed individuals, business entities filling articles of incorporation, partnerships, limited partnerships, limited liability companies, foreign corporations, foreign limited partnerships, foreign liability companies authorized to transact business in this state, business trusts, and any business entity that registers with the Secretary of State.
- b. Any business entity that possesses a business license, permit, certificate, approval, registration, charter, or similar form of authorization issued by the state, any business entity that is exempt by law from obtaining such a business license, an any business entity that is operating unlawfully without a business license.

CONTRACTOR. A person, employer, or business entity that enters into an agreement to perform any service or work or to provide a certain product in exchange for valuable consideration. This definition shall include, but not be limited to, a general CONTRACTOR, sub-CONTRACTOR, independent CONTRACTOR, contract employee, project manager, or a recruiting or staffing entity.

EMPLOYEE. Any person directed, allowed, or permitted to perform labor or service of any kind by an employer. The employees of an independent CONTRACTOR working for a business entity shall not be regarded as the employees of the business entity, for the purposes of this chapter. This term does not include any inmate in the legal custody of the state, a county, or a municipality.

EMPLOYER. Any person, firm, corporation, partnership, joint stock association, agent, manager, representative, foreman, or other person having control or custody of any employment, place of employment, or of any employee, including any person or entity employing any person for hire within the State of Alabama, including a public employer. This term shall not include the occupant of a household contracting with another person to perform casual domestic labor within the household.

E-VERIFY. The electronic verification of federal employment authorization program of the Illegal Immigration Reform and Immigrant Responsibility Act of 1996, P.L. 104-208, Division c, Section 403 (a); 8 U.S.C. §1324(a), and operated by the United States Department of Homeland Security, or its successor program.

STATE-FUNDED ENTITY. Any governmental entity of the state or a political subdivision thereof or any other entity that receives any monies from the state or a political subdivision thereof; provided, however, an entity that merely provides a service or a product to any governmental entity of the state or a political subdivision thereof, and receives compensation for the same, shall not be considered a state-funded entity.

SUB-CONTRACTOR. A person, business entity, or employer who is awarded a portion of an existing contract by a CONTRACTOR, regardless of its tier.

UNAUTHORIZED ALIEN. An alien who is not authorized to work in the United States as defined in 8 U.S.C. § 1324a (h) (3).

3.0 Mandatory Clause

All contracts or agreements to which the state, a political subdivision, or state-funded entity are a party shall include the following clause:

"By signing this contract, the contracting parties affirm, for the duration of the agreement, that they will not violate federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the state of Alabama. Furthermore, a contracting party found to be in violation of this provision shall be deemed in breach of the agreement and shall be responsible for all damages resulting therefrom."

For purposes of this section, "contract" shall mean a contract awarded by the state, any political subdivision thereof, or any state-funded entity that was competitively Quote or would, if entered into by the state or an agency thereof, be required to be submitted to the Contract Review Permanent Legislative Oversight Committee.

4.0 Contracts Involving Business Entity, or Employer

As a condition for the award of any contract, grant, or incentive by the state, any political subdivision thereof, or any state-funded entity to a business entity or employer that employs one or more employees, the business entity or employer shall not knowingly employ, hire for employment, or continue to employ an unauthorized alien within the State of Alabama.

As a condition for the award of any contract, grant, or incentive by the state, any political subdivision thereof, or any state-funded entity to a business entity or employer that employs one or more employees within the state of Alabama, <u>the business entity or employer shall</u> <u>provide documentation establishing that the business entity or employer is enrolled in</u> <u>the E-Verify program.</u> During the performance of the contract, the business entity or employer shall participate in the E-Verify program and shall verify every employee that is required to be verified according to the applicable federal rules and regulations.

5.0 Contracts Involving Subcontracting

Any sub-contractor on a project paid for by contract, grant, or incentive by the state, any political subdivision thereof, or any state-funded entity shall not knowingly employ, hire for employment, or continue to employ an unauthorized alien within the State of Alabama and shall also enroll in the E-Verify program prior to performing any work on the project. Furthermore, during the performance of the contract, the sub-contractor shall participate in the E-Verify program and shall verify every employee that is required to be verified according to the applicable federal rules and regulations. This subsection shall only apply to sub-contractors performing work on a project subject to the provisions of this section and not to collateral persons or business entities hired by the sub-contractor.

6.0 Proof of E-Verify documentation will be in the form of a copy of the signed Memorandum Of Understanding (MOU) generated upon completion of the E-Verify program.

The City of Fairhope has adopted the 2018 International Code Series as well as the Baldwin County High Wind Supplement for roofs. This adoption is codified in Appendix 1 of the City of Fairhope Building Code Supplement, which can be viewed at <u>https://www.fairhopeal.gov/home/showdocument?id=22784</u>

To clarify some questions we have received regarding the requirements for storm damage repairs:

All new and replacement roofs will be required to meet the requirements of the Baldwin County Roofing Supplement and sealed roof deck requirements (see attached). Further clarification is listed below:

- Roof replacement will be required of there is distributed damage throughout most or all of the roof (see photos).
- Localized damage equaling 1 Square or less of roofing material (10'x10' area) will be allowed to repair just the damage area. This will typically apply to roof damage resulting from impact to the structure from a tree or similar (see attached photos).

All roofing repairs will require a permit be issued by the Fairhope Building Department and all roofing contractors will be required to have both an Alabama Homebuilders Licensure Board Roofing license and a City of Fairhope Business license.

Asphalt shingles shall be installed according to the manufacturer recommended listed installation instructions for High Wind areas (130 mph ASTM D7158 Class H shingle) with minimum 6 nails.

All asphalt shingle roof covering underlayment shall be of a synthetic tear resistant (20 lbs. per ASTM D1970 or ASTM D4533) polypropylene, polyester or fiberglass fabric and certified by an approved testing agency or ICC-ES report. The Building Official may approve an equal greater performing product. Roof underlayment shall be installed per Manufacturer's Installation Instructions **but**, shall not be fastened with staples.

Metal panel roofing systems and their attachment shall be installed in accordance with the manufactures installation instructions and shall provide uplift resistance equal to or greater than the design uplift pressure for the roof. The metal panels shall be installed over continuous decking and one of the acceptable secondary water barrier underlayment options.

2X4 or 1X4 wood purlin for attachment of metal roof coverings shall be spaced per manufacturer installation instructions but no greater than 2 foot OC. Wood purlin shall be nailed with a minimum 2 deformed (ring shank) nails penetrating into roof framing 1 ½ inch.

Roof decking shall be nailed in accordance with the engineered drawings but no greater than 4 inches OC both edge and field within the 4 foot roof edge zone and maximum 6 inches OC edge and field all other locations. Decking shall be fastened with minimum 8d full round head ring shank nails. Staples will not be permitted.

Roof decking shall be "sealed". All sheathing seams shall be taped with minimum 4 inch Peel and Stick tape or full sheet Peel and Stick meeting ASTM D1970, or spray polyurethane closed cell foam adhesive (meeting ASTM D1622) shall be applied over all joints between sheathing and along all intersections between roof sheathing and all roof framing members. Other equal or greater methods may be approved by the Building Official.

All aluminum and vinyl Soffit covering shall be attached to minimum 7/16 OSB or plywood or minimum 2 X 2 wood supports equally spaced but not greater than 12 inches OC.

Replacement of roof covering and underlayment of existing One and Two Family dwelling shall require a roofing permit from the City of Fairhope Building Department. All roof coverings and underlayment shall be removed and any roof decking attached with staples or nailing pattern exceeding minimum requirements shall be re-nailed with 8d ring shank to meet requirement. Roof deck shall be "sealed" as described above.

APPENDIX D

D102.2 Other specific requirements.

D102.2.1 Exterior walls. Exterior walls of buildings located in the fire district shall comply with the requirements in Table 601 except as required in Section D102.2.6.

Fire-resistant separations between buildings, either by distance or barriers, as described by Table 601, protect against fire spread by radiant and convective heat transfer and, to a limited extent, from small flying brands.

D102.2.2 Group H prohibited. Group H occupancies shall be prohibited from location within the fire district.

Group H-1, H-2, H-3 and H-5 hazardous occupancies are prohibited within the fire district because of the fire hazard posed by these occupancies themselves. Group H-4 occupancies are prohibited due to the inherent danger of release and contamination posed should occupancies containing highly toxic, toxic, radioactive or other health-hazard materials be exposed to fire. D102.2.3 Construction type. Every building shall be constructed as required based on the type of construction indicated in Chapter 6.

This section reinforces the need for new buildings to be constructed as required based on height and area and type of construction considerations in the body of the code.


D102.2.4 Roof covering. Roof covering in the fire district shall conform to the requirements of Class A or B roof coverings as defined in Section 1505.

Class C and wood-shake shingle roofs are prohibited within the fire district due to the danger of fire spread and involvement through production of or exposure to burning brands.

D102.2.5 Structural fire rating. Walls, floors, roofs and their supporting structural members shall be not less than 1-hour fire-resistance-rated construction.

Exceptions:

1. Buildings of Type IV construction.
