The City Council, City of Fairhope, met in special emergency session a 9:15 a.m. via Teleconference necessary to "perform essential minimum functions of the governmental body," 161 North Section Street, Fairhope, Alabama 36532, on Wednesday, 28 October 2020.

Present were Council President Jack Burrell, Councilmembers: Jay Robinson, Jimmy Conyers, and Robert Brown, City Attorney Marcus McDowell, and City Clerk Lisa A. Hanks. Councilmember Kevin Boone and Mayor Karin Wilson were absent.

There being a quorum present, Council President Burrell called the meeting to order at 9:22 a.m.

Council President Burrell announced that the Special Emergency Meeting was called to discuss two resolutions related to Hurricane Zeta.

Councilmember Robinson introduced in writing, and moved for the adoption of the following resolution, a resolution that the City Council of the City of Fairhope hereby declares an emergency effective immediately on Wednesday, October 28, 2020 associated with Hurricane Zeta with the potential to make landfall in or near Louisiana and tropical storm force winds predicted for Mobile and Baldwin counties; and hereby authorizes and directs the Mayor/Mayor Pro Tempore and City Clerk to execute and attest, respectively, all contracts determined to be necessary to meet this emergency. Seconded by Councilmember Brown, motion passed unanimously by voice vote.

RESOLUTION NO. 3864-20

WHEREAS, Governor Kay Ivey declared a "State of Emergency in the State of Alabama effective on Tuesday, October 27, 2020" which was associated with Hurricane Zeta with the potential to make landfall in or near Louisiana and tropical storm force winds predicted for Mobile and Baldwin counties; and

WHEREAS, the City Council of the City of Fairhope hereby declares a State of Emergency within the City of Fairhope effective immediately on October 28, 2020 due to Hurricane Zeta within the meaning of Alabama Code Section 39-2-2(e); and

WHEREAS, that the Mayor/Mayor Pro Tempore and City Clerk are hereby authorized and directed to execute and attest, respectively, all contracts determined to be necessary to meet the emergency without public advertisement pursuant to the Code of Alabama; and
