GENERAL SCOPE

- 8.01 The Awarded Vendor to provide the following equipment per Specifications:
- 8.01.1 Provide all labor, materials, and equipment to furnish, deliver and erect a 40'X40'x16.5' preengineered Metal Building, including column reactions and anchor bolts for the foundation, which is to be provided by City per said reactions, anchor bolts and specifications provided by the Awarded Vendor.
