The City Council, City of Fairhope, met in regular session at 6:00 p.m., Fairhope Municipal Complex Council Chamber, 161 North Section Street, Fairhope, Alabama 36532, on Monday, 13 September 2021.

Present were Council President Jack Burrell, Councilmembers: Corey Martin, Jimmy Conyers, Jay Robinson, and Kevin Boone, Mayor Sherry Sullivan, City Attorney Marcus E. McDowell, and City Clerk Lisa A. Hanks.

There being a quorum present, Council President Burrell called the meeting to order at 6:03 p.m. The invocation was given by Senior Pastor Kyle Parker of Eastern Shore Presbyterian Church in America and the Pledge of Allegiance was recited.

Council President Burrell stated there was a need to add on an agenda item after Agenda Item Number 27: a resolution that the City Council hereby adopts and incorporates a field use agreement for general field and tournament use of its several sports complex facilities. All other field use agreements currently in place are hereby repealed; specifically, Resolution No. 3736-20.

Councilmember Martin moved to add on the above-mentioned item not on the printed agenda. Seconded by Councilmember Boone, motion passed unanimously by voice vote.

Councilmember Robinson moved to approve minutes of the 23 August 2021, regular meeting; minutes of the 23 August 2021, work session; and minutes of the 23 August 2021, agenda meeting; and minutes of the 28 August 2021 special-called City Council meeting. Seconded by Councilmember Conyers, motion passed unanimously by voice vote.

Mayor Sullivan addressed the City Council and gave the following proclamations: Constitution Week, September 17th through September 23rd each year; and September as Childhood Cancer Awareness month. Jennifer Berry accepted the Childhood Cancer Awareness Proclamation and told the City Council she lost her child to cancer. Ms. Berry said, "Go Gold."

Mayor Sullivan announced the Comprehensive Plan kickoff meeting on September 22, 2021 from 6:00 p.m. to 8:00 p.m. at the James P. Nix Center. She reminded everyone about the Alabama Coastal Cleanup this Saturday at the Municipal Pier. Mayor Sullivan said there will be a Budget Work Session prior to the next City Council meeting; and welcomed Gas Superintendent Terry Holman back.

The following individuals spoke during Public Participation for Agenda Items:

- 1) Chris Riley, citizen of Fairhope and member of the Pedestrian and Bicycle Committee, addressed the City Council regarding Agenda Item No. 23: a Resolution that the City Council approves the full scope of work and authorizes continuing work on the engineering for Phase I of the "Working Waterfront and Green Space Project Fairhope Municipal Pier and South Beach Park Improvements." He said this would make it possible for him to have access to the pier from the top of the bluff. Mr. Riley said he has never been up on the bluff and would love to have access.
- 2) Chris Knight, 50 N. Bayview, addressed the City Council regarding Agenda Item No. 23: a Resolution that the City Council approves the full scope of work and authorizes continuing work on the engineering for Phase I of the "Working Waterfront and Green Space Project Fairhope Municipal Pier and South Beach Park Improvements." He suggested a Design Team to look at other options; and mentioned an elevator being less invasive. He commented you would see more constructive ideas. Mr. Knight said the water quality is unacceptable.

Councilmember Robinson congratulated the Fairhope Football teams.

Councilmember Conyers thanked everyone who attended Friday morning for the 911 Ceremony and the dedication of the building. He said that Joe Petties is a great man.

Councilmember Martin said the program was awesome to have a building named after Joe Petties. He mentioned Larry Houston playing at the pier and the City had a complaint. Councilmember Martin said he wants to personally invite Mr. Houston back who has been a blessing to many during our situation. He commented we can work something out.

A Public Hearing was held as advertised on a proposed ordinance to amend Zoning Ordinance No. 1253. Councilmember Robinson introduced in writing an ordinance to zone the property of Silverhill Enterprises, LLC to Planned Unit Development (PUD) concurrent with annexation into the City of Fairhope. The property generally located east and west of Highway 181 near The Waters Subdivision, Fairhope, Alabama. PPIN Numbers: 17737, 17735, and 77776. The property to be known as <u>Harvest Green PUD</u>. The Planning Commission gave a favorable recommendation of this ordinance. Council President Burrell read the proposed ordinance.

Planning and Zoning Manager Hunter Simmons briefly explained the proposed ordinance; and said the development is on the East and West side of Highway 181.

Councilmember Martin questioned water for the development. Mayor Sullivan said she is meeting with developers to discussion how this impacts our system; and appreciates these annexations into the City. Council President Burrell said it is good they are annexing into City. Mayor Sullivan said she appreciates the local developers caring about the City.

Council President Burrell opened the Public Hearing at 6:38 p.m.

Larry Smith, Civil Engineer for the Developer, addressed the City Council and stated he had several meetings with Mayor Sullivan and Water and Sewer Superintendent Jason Langley. Mr. Smith commented he looked at infrastructure along Highway 181 not just this PUD.

No one present opposed the proposed ordinance, the Public Hearing closed at 6:39 p.m.

Due to lack of a motion for immediate consideration, this ordinance will layover until the September 27, 2021 City Council meeting.
