The City Council, City of Fairhope, met in regular session at 6:00 p.m., Fairhope Municipal Complex Council Chamber, 161 North Section Street, Fairhope, Alabama 36532, on Monday, 14 March 2022.

Present were Council President Jimmy Conyers, Councilmembers: Corey Martin, Jay Robinson, and Kevin Boone, Mayor Sherry Sullivan, City Attorney Marcus E. McDowell, and City Clerk Lisa A. Hanks. Councilmember Jack Burrell was absent.

There being a quorum present, Council President Conyers called the meeting to order. The invocation was given by Reverend De Freeman of St. James Episcopal Church and the Pledge of Allegiance was recited.

Council President Conyers stated there was a need to add on three agenda items after Agenda Item Number 15: a resolution that the City of Fairhope approves the procurement of Fels Park Fencing for the Recreation Department with a cost not-to-exceed \$19,361.00; a resolution that the City of Fairhope has voted to purchase a VTScada Services for the Electric Department, from Deep South Automation, LLC as Sole Source Distributor for Trihedral, Inc; and authorizes procurement based on the option allowed by the Code of Alabama 1975, Section 41-16-51(13) with the cost of \$9,700.00; and an application for Restaurant Liquor License by Sean C. Travis, Eastern Shore Street Treats LLC DBA Sean's Prime Dining, 58 N. Section Street, Fairhope, AL.

Councilmember Robinson moved to add on the above-mentioned items not on the printed agenda. Seconded by Councilmember Boone, motion passed unanimously by voice vote.

Councilmember Robinson moved to approve minutes of the 4 March 2022, regular meeting. Seconded by Councilmember Martin, motion passed unanimously by voice vote.

Mayor Sullivan addressed the City Council and reminded everyone of the Arts and Crafts Festival, Live at Five Concert, Junior City Council Project, and the Comprehensive Plan Meetings with conceptual view.

Chief Stephanie Hollinghead addressed the City Council regarding the promotions in the Police Department ("PD"): Captain John Hamrick (17 Years with PD), Lieutenant David Hall (17 years with PD), Sergeant Charles Varnado (15 years with PD), School Resource Officer Corporal Bunky Bishop (18 years with PD), Corporal Brett Dahlmann (7 years with PD), and Corporal Tyler Sellers (7 years with PD). Chief Hollinghead said the promotions were well deserved and they worked extremely hard for these positions.

Chief Hollinghead announced the Officer of the Quarter for the Fourth Quarter was Officer Roderick Bolden who is a School Resource Officer at Fairhope East. She said he always participates in "Shop with a Cop" and told the City Council what Ms. Broughton told her; about what Officer Bolden does for families.

The following individual spoke during Public Participation for Agenda Items:

 Skip Jones, President for Fairhope Writing Center for the Writing Arts, Inc., addressed the City Council and explained its partnership with the City. He thanked the Mayor and City Council for the use of the Wolff Cottage; and mentioned the vast number of writers already booked to use it.

Councilmember Boone mentioned attending a Police Simulating Course and said he was shot twice. He stated the training was important and thanked the Police Department.

Councilmember Martin introduced in writing Ordinance No. 1747, an ordinance to declare that certain real property of the City of Fairhope (Writer's Cottage at 9 North Section Street) for Fairhope Center for the Writing Arts, Inc. is not needed for public or municipal purposes in response to an offer to lease property to be used only as a center for the writing arts and in accordance with uses normally incident to hereto and for no other purpose; and it is hereby declared to be in the best interest of the public and the City of Fairhope, Alabama, to lease said real property to Fairhope Center for the Writing Arts, Inc. with a lease term of five years with an option to renew for an additional five years. Renewal shall only be valid on approval by City Council. In order to take immediate action, Councilmember Boone moved for immediate consideration. Seconded by Councilmember Martin, motion for immediate consideration passed unanimously by the following voice votes: AYE - Martin, Conyers, Robinson, and Boone. NAY – None. Councilmember Boone then moved for final adoption of Ordinance No. 1747. Seconded by Councilmember Robinson, motion for final adoption passed by the following voice votes: AYE - Martin, Conyers, Robinson, and Boone. NAY - None.
