Quail Creek Patrons:

- -We are aware that there is an issue with the greens at QC. We have sent soil samples out for analysis and know the issues. We have a plan and hope to save the green but know that we have a long way to go and may not be able to save them all. We need some warm weather and lots of prayer! We do have a plan moving forward.
 - -The play at QC has increased considerably and has been up for the past year (this is a good thing!), allowing little time for maintenance and for the greens to rest. We are seeing this same issue all over Fairhope, especially in recreational parks.
- Starting in May, we will push tee times back to Noon on Thursdays and have adjusted the hours of the maintenance crews. This will give times for maintenance of the greens and allow chemicals time to dry.
- We have hired Tomm Johnson. He is resident of Fairhope and has played QC for the past several years. He understands the challenges we have and is highly qualified. We are lucky to have him working for QC and know he is exactly what our course needs right now. His resume is attached.
- -Please be patient as we work through these challenges. At times, you may be inconvenienced but we will do our best to be good communicators and limit interruptions. We have lots of opportunity at QC and look forward to things being better than ever in the coming months.
 - As always, the Mayor and Bobby are always available for questions or concerns.
 - Quail Creek has been without a Superintendent since November 2021.
 - Previous agronomic cultures were not used for the prevention of the current interruptions. We are aware of the situation and improving every day with Tomm Johnson's experience a fantastic knowledge!
 - Greens are our #1 priority. We have aerified several greens to give Bermuda an opportunity to grow in
 - Unfortunately, Poa anna is throughout the course will grow out with warmer weather.
 - Spaying for Mole Crickets will begin soon
 - Mowing heights have been increased. Greens will NOT be mowed until the week of April 18th!
