The City Council, City of Fairhope, met in regular session at 6:00 p.m., Fairhope Municipal Complex Council Chamber, 161 North Section Street, Fairhope, Alabama 36532, on Monday, 25 April 2022.

Present were Council President Jimmy Conyers, Councilmembers: Jack Burrell, Corey Martin, Jay Robinson, and Kevin Boone, Mayor Sherry Sullivan, City Attorney Marcus E. McDowell, and City Clerk Lisa A. Hanks.

There being a quorum present, Council President Conyers called the meeting to order. The invocation was given by Pastor Rick Malugani of Fairhope Christian Church and the Pledge of Allegiance was recited.

Council President Conyers stated there was a need to amend the by deleting the Executive Session and adding agenda items after Agenda Item Number 20: a resolution that the City of Fairhope authorizes submission of an HMGP grant to AEMA requesting grant funds to purchase and install state-of-the-art siren warning systems for mass notification; a resolution that the City of Fairhope has voted to purchase one (1) 1000KVA 3 Phase Pad Mount Transformer and three (3) 150KVA 3 Phase Pad Mount Transformers from TransArmour Inc for three (3) businesses and inventory; and authorizes procurement without formal bid based on the option allowed by the Code of Alabama 1975, Section 41-16-51(b)(7). The cost not-to-exceed \$103,250.00; and a resolution that Mayor Sherry Sullivan is hereby authorized to execute a Mutual Release and Settlement Agreement between the City of Fairhope and GreenCo Services, LLC relating to the contract for dredging operations at the Fairhope Marina.

Councilmember Burrell moved to delete the Executive Session and to add on the above-mentioned items not on the printed agenda. Seconded by Councilmember Boone, motion passed unanimously by voice vote.

Councilmember Burrell moved to approve minutes of the 11 April 2022, regular meeting; and minutes of the 11 April 2022, work session. Seconded by Councilmember Robinson, motion passed unanimously by voice vote.

Mayor Sullivan addressed the City Council and welcomed Troop 47 Boy Scouts who were in the audience working on their Citizenship Badge: Ian Mitchum and Channel Wesley. She thanked Gary Gover and everyone involved in Mobile Bay Earth Day.

25 April 2022

Mayor Sullivan announced the dedication of the new solar charging station, part of Alabama Municipal Electric Authority's new 50-KW solar research project at 10:00 a.m., Wednesday, May 4th, in the Fairhope City Hall parking lot, 161 North Section Street, Fairhope, AL 36533. She said that the road closing at the Fairhope Avenue and Church Street intersection should be opened on May 2, 2022; and there would be a road closure on Fairhope Avenue to prepare a sewer force main.

The following individual spoke during Public Participation for Agenda Items:

- 1) Skip Jones, President of the Fairhope Center for the Writing Arts, Inc., addressed the City Council regarding Agenda Item No. 5: an ordinance to repeal and replace Ordinance No. 1747; and request to approve the revised lease to the Fairhope Center for the Writing Arts, Inc. declaring that certain real property of the City of Fairhope (Writer's Cottage at 9 North Section Street) for Fairhope Center for the Writing Arts, Inc. He thanked the City Council for renewing the lease and for repairing the roof.
- 2) Gary Gover, 300 Lincoln Street, addressed the City Council regarding Agenda Items No. 8 and No. 9: a resolution that the City of Fairhope authorizes the submission of a grant application to ADCNR for 22 generators to be located at key wastewater lift stations to provide continuous public wastewater operations during storm events and, therefore, reduce the number of Sanitary Sewer Overflows that occur; and a resolution that the City of Fairhope authorizes the submission of a grant application to ADCNR for the Storm Water Infrastructure Inventory, a comprehensive GIS digital inventory of existing stormwater infrastructure features throughout the City of Fairhope that convey into Mobile Bay, a Repetitive Flood Loss Assessment, and an update of the City's Storm Water Management Plan. He asked if there are batteries or diesel fuel for the generators; and questioned the load on lift stations. He asked about the storm water infrastructure. Mr. Gover also asked about Agenda Item No. 12: a resolution that the City Council hereby approves and authorizes Mayor Sherry Sullivan to execute a Memorandum of Understanding (MOU) Agreement between the City of Fairhope and Maison Jaycie Condominium Owners Association (COA), a Private Property Owner's Condominium Association for a Slope Stabilization Project. He mentioned our living shoreline.

Councilmember Burrell said these are standby generators and said the load can be handled. Public Works Director Richard Johnson said we will use natural gas or diesel fuel in the generators.

Councilmember Burrell mentioned the passing of Bob Riggs; and said he was very involved in the Harbor Board, the Education Advisory Committee, and the Finance Committee. Councilmember Burrell stated Mr. Riggs was working on his boat when he passed. He said Mr. Riggs was a retired Colonel. Councilmember Burrell sent his sympathy to the Riggs family and his wife Vickey.

25 April 2022

Councilmember Martin mentioned the new member for the Recreation Board; and commented what great things Recreation Director Pat White is doing: Ball Parks, Pickleball, etc. Juneteenth special event, on June 18, 2022, at the Fairhope-Point Clear Rotary Youth Club with activities for family and kids. Juneteenth is now recognized as a National Holiday.

Council President Conyers commented Mr. White and staff did a great job handling the concession stand this past weekend; he thanked Mr. White for a successful weekend.

Councilmember Martin moved for final adoption of Ordinance No. 1750, an ordinance to repeal and replace Ordinance No. 1747; and request to approve the revised lease to the Fairhope Center for the Writing Arts, Inc. declaring that certain real property of the City of Fairhope (Writer's Cottage at 9 North Section Street) for Fairhope Center for the Writing Arts, Inc. is not needed for public or municipal purposes in response to an offer to lease property to be used only as a center for the writing arts and in accordance with uses normally incident to hereto and for no other purpose. (Introduced at the April 11, 2022 City Council Meeting) Seconded by Councilmember Burrell, motion for final adoption passed by the following voice votes: AYE – Burrell, Martin, Conyers, Robinson, and Boone. NAY - None.

Planning Director Hunter Simmons addressed the City Council to explain the Site Plan Review of property owned by FST 412 Fairhope, LLC. Located at the 412 Fairhope Avenue, Fairhope, Alabama for a proposed a 3-Unit Multiple-Occupancy Project. The subject property is zoned B-2 Central Business District and is approximately 0.07 acres. The property is located on the southern side of Fairhope Avenue and lies east of Section Street. PPIN Number: 15148. (Planning Commission unanimously voted to recommend City Council approve SR 22.04) Staff recommends conditional approval of Case SR 22.04 with the following condition: 1.) Redesign of the balcony to resolve the conflict with the existing street tree.

Councilmember Burrell said he spoke with the owner; and stated the tree is under the balcony and cannot be trimmed. Councilmember Burrell commented he supports the site plan with the two recommendations; but we can do a solution for both. Architect Ryan Baker said with a triangle, no vehicle can park and would be a tree well. He said an eight foot balcony would fit. Larry Smith with S. E. Civil commented it would impact the other parking spot. Brian Britt, owner of property, said that only a fork of the tree is under the balcony; and other balconies trees have been trimmed. He commented if the tree were on the property line there would be no issue.

Council President Conyers suggested taking one to two feet off the balcony and trim the tree. Councilmember Burrell said the tree is under the balcony so trimming would not help. Councilmember Robinson said he wants more options.

Mr. Simmons said the tree would have to be trimmed on two sides; and mentioned the proposed Right-of-Way Ordinance allows up to a four foot balcony. Council President Conyers said to trim tree and move balcony back a little.

Councilmember Robinson moved to table the Site Plan property owned by listed above. Seconded by Councilmember Burrell, motion passed unanimously by voice vote.

Councilmember Robinson introduced in writing, and moved for the adoption of the following resolution, a resolution that the public improvements indicated herein for Long Pines Estates Unit One are hereby accepted for public maintenance. - (c) Continue to develop maintenance alarms within the SCADA System that encourage a proactive maintenance response to prolong the useful life of pumps and motors in the system.
- (d) Use the SCADA System using system storage and future side stream storage systems when available.
- (e) Continue to perform O & M requirements to the treatment and collection system and complete repairs when discovered.

**WHEREAS**, the City's Public Utilities Department will provide oversight of the project, if funded;





The following individual spoke during Public Participation for Non-Agenda Items:




