#### Minutes of the Fairhope Recreation Board

The Fairhope Recreation Board met on Wednesday, June 22, 2022, at 5:15 p.m. in the Rec Center at 803 North Greeno Road.

Present: Charlie Langham, Haden Giddings, Pat White, Cathy Hudson, Lisa Atchley, Scott Berry, Corey Martin and Maurice Morrisette. Absent: Derek Thomas and Jack Burrell.

The meeting was called to order by Charlie Langham at 5:14 p.m. The minutes of the June 22, 2022, meeting minutes were considered and approved on a motion by Corey Martin, seconded by Lisa Atchley, none opposed.

Guest: Gary Govers, John Cocke, Jacque Boyer, Declan, Steven Hazelwood, and Charlie(unsure of last name).

**Fairhope Soccer Club/Academy Update:** John Cocke, Jacque Boyer and Declan (all representatives of Fairhope Soccer Club/Academy) spoke to the Rec Board and wanted to clear up any misconceptions anyone has over the program and their finances. Steven Hazelwood spoke to the Rec Board and stated that if it becomes necessary for the City to form a Recreational Youth Soccer League, he and a handful of others would be willing to donate their time and coach.

**Disc Golf Update:** Charlie, guest speaker, spoke to the Rec Board regarding the popularity of Disc Golf around Baldwin County and how it would be beneficial to have a few new courses in and around Fairhope.

#### **Recreation Updates:**

Pat White informed the Rec Board that Charlie Williamson has resigned as President of the Rec Board, effective immediately, as he has moved to Daphne; Youth Baseball held their District Tournament for 9u at the beginning of June and everything went well and 2 of the youth leagues will represent Fairhope in the State tournament sometime in July; The new youth baseball fields are coming along and we are hopeful to have those ready in time for the spring 2023 season; The front youth baseball field is currently being transformed into additional parking; Stu Fuller has resigned as Fairhope High School's head baseball coach and it is unsure who will be taking over as of this moment; Rotary Youth Club has received new parking/gravel and auto irrigation system in the garden area just in time for the Juneteeth celebration on Saturday, June 18<sup>th</sup>, which was a tremendous hit; Budget review meetings for Parks & Recreation are already starting for the next fiscal year.

Corey Martin mentioned that the City Council has been getting calls from parents involved in the youth baseball program about helping maintain the fields because the fields are not looking as well as they had hoped. Pat informed Corey and the rest of the Rec Board

members that he would prefer no one else work on the fields, that all him and his guys need is time without being practiced/played on.

#### **Recreation New Business:**

There was general discussion about recommending the City setting up a legal entity and forming an actual City of Fairhope Recreational Youth Soccer League. Scott Berry made a motion to approve the recommendation to Council from the Rec Board to form the legal entity under City of Fairhope Recreational Youth Soccer League and Lisa Atchley second the motion, none opposed. (Haden Giddings did not vote)

There was general discussion regarding filling the empty position of the Rec Board President. Corey Martin made the motion for Lisa Atchley to be appointed Rec Board President and Maurice Morrisette second the motion, none opposed.

Being no further business, the meeting was adjourned at 6:26 p.m.
