The City Council, City of Fairhope, met in regular session at 6:00 p.m., Fairhope Municipal Complex Council Chamber, 161 North Section Street, Fairhope, Alabama 36532, on Monday, 12 September 2022.

Present were Council President Jimmy Conyers, Councilmembers: Jack Burrell, Corey Martin, Jay Robinson, and Kevin Boone, Mayor Sherry Sullivan, City Attorney Marcus E. McDowell, and Assistant City Clerk Jenny Opal Wilson. City Clerk Lisa Hanks was absent.

Council President Conyers stated that Agenda Item Number 24 was pulled from the agenda.

Councilmember Robinson moved to approve minutes of the 22 August 2022, Regular Meeting; and minutes of the 22 August 2022, Work Session. Seconded by Councilmember Boone, motion passed unanimously by voice vote.

Mayor Sullivan addressed the City Council and gave the following Proclamations: Constitution Week, September 17th through September 23rd each year, and September as Childhood Cancer Awareness Month. Webb Jackson and Abby Eubanks, Board Members of Joy of Life on the Gulf Coast accepted Childhood Cancer Awareness Proclamation. Mayor Sullivan thanked them for their attendance.

Mayor Sullivan thanked the Police Department and Fire Department for commemorating the 9-11 Memorial Ceremony. She reminded everyone about the Alabama Coastal Cleanup this Saturday, September 17th at the Municipal Pier. If your not assigned to a location and would like to participate you can show up at pier and will be assigned. Hot dogs, chips and drinks will be served after cleanup. Great time to clean up our community and beaches.

The following individual spoke during Public Participation for Agenda Items:

1) JJ McCool, 282 Creek Drive, addressed the City Council regarding Agenda Item No. 11 a Resolution that the City Council hereby approves and amends the Rules and Regulations for the "Fairhope Docks" for paragraphs 21, 30, 32 and 33.
