Clarifications:

 The City has an existing Disaster Debris Removal contract to be used during and after a state of emergency has been declared (i.e., hurricanes). This contract will not be used in those circumstances.

Questions Submitted During the Pre-Bid Meeting:

- 1. Emergency Tree Removal What if the conditions are not favorable to tree removal when the contractor is called (i.e., lightning, or electrical wires present)?
 - A. If the Contractor and the City determine that the work conditions are not safe for the Contractor during the "Emergency" time window, then the City will change the request to be a non-emergency and the tree removal will be scheduled when the work conditions are safe.
