(Morrow Water), submitted a bid per the requirements of Bid No. 24-034. Templeton and Associates Equipment Sales, Inc. (Templeton) submitted a bid, but did not meet the requirements of the bid. It should be noted that the bid submitted by Templeton was higher than the bid submitted by Morrow Water. The bid received was as follows:



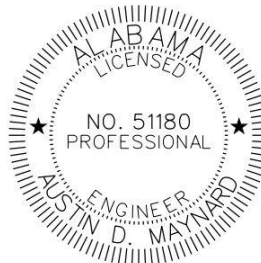
