The City Council, City of Fairhope, met in regular session at 6:00 p.m., Fairhope Municipal Complex Council Chamber, 161 North Section Street, Fairhope, Alabama 36532, on Monday, 26 October 2015.

Present were Council President Jack Burrell, Councilmembers: Rich Mueller, Diana Brewer, Michael A. Ford, and Kevin Boone, Mayor Timothy M. Kant, City Attorney Marion E. Wynne, and City Clerk Lisa A. Hanks.

There being a quorum present, Council President Burrell called the meeting to order. The invocation was given by Associate Pastor Chris Peters of Trinity Presbyterian Church and the Pledge of Allegiance was recited. Councilmember Boone moved to approve minutes of the 12 October 2015, regular meeting; minutes of the 12 October 2015, work session; minutes of the 12 October 2015, agenda meeting, minutes of the 8 October 2015, special called meeting, and minutes of the 8 October 2015, budget meeting. Seconded by Councilmember Mueller, motion passed unanimously by voice vote.

Mayor Kant addressed the City Council regarding the following items:

- 1) Thanked the City Council for the appropriations; and
- Recognized Jenny Douglas for her 12 years serving on the Recreation Board. Councilmember Brewer commented she was one of the best teachers at Fairhope Elementary.

Council President Burrell stated there was a need to add on two agenda items after Agenda Item Number 38: a Resolution to award RFQ for HVAC Emergency Repairs at Library due to Lightning Strike (RFQ Number 002-16) to Comfort Systems USA Southeast with a total cost of \$33678.00; and a Resolution to authorize Mayor Kant to execute an Agreement with the State of Alabama, acting by and through the Alabama Department of Transportation, for the resurfacing of Fairhope Avenue from Bancroft Street to SR-181. Length – 2.63 miles. Project# ACOA61156-ATRP (002); ATRIP# 02-05-40.

Councilmember Brewer moved to add on the above mentioned items **not** on the printed agenda. Seconded by Councilmember Boone, motion passed unanimously by voice vote.

Council President stated there was a need to add on an agenda item after the two resolutions that have been added to the agenda; a Resolution that Mayor Kant is hereby authorized to sign the change order for The Woodlands Drainage Restoration Project, to add an increase in cost of \$17,977.24 to be paid to Ammons & Blackmon; and to negotiate a reasonable increase in engineering costs caused by the extension of improvements to the sewer line.

She requested the City Council to not take away our public pier. People are walking and there are children on the pier. It is great for the handicap as is with a handrail and it is flat.
- 2) Cori Yonge, 111 Keifer Avenue, addressed the City Council regarding Agenda Item Number 37; Golf Green Fees for the Fairhope Educational Enrichment Foundation ("FEEF") Tournament. Ms. Yonge thanked the City Council on behalf of FEEF; and also thanked Michael Stonehouse, Sherry Sullivan, Lisa Hanks, and Bobby Hall for their help throughout the year with FEEF events.
- 3) Stephanie Reeves, Kay Owen, and Alex Robinson, on behalf of the Downtown Fairhope Business Association, addressed the City Council regarding Agenda Item Number 29; Resolution for approving the \$20,000.00 appropriation. They thanked the Mayor and City Council for the generous donation and said they have approximately 130 members this year.
- 4) Charlene Lee, on behalf of the Baldwin County Trailblazers, addressed the City Council regarding Agenda Item Number 21; Resolution for approving the \$5,000.00 appropriation to support Smart Walks. She thanked the City Council for supporting the Walking School Bus; and the International Walk to School which honored Teko Wiseman this year.
- 5) Mary Riser, on behalf of the Fairhope Film Festival, addressed the City Council regarding Agenda Item Number 24; Resolution for approving the \$10,000.00 appropriation. She thanked the City Council for their support; and mentioned having 58 films in a four day period.
- 6) Mark Stejskal, on behalf of the Fairhope-Point Clear Rotary Youth Club, addressed the City Council regarding Agenda Item Number 25; Resolution for approving the \$55,000.00 appropriation. He thanked the City Council and Mayor for their support.

- 7) Ormand Thompson, President of Thomas Hospital, addressed the City Council regarding Agenda Items Number 31 and Number 36; Resolutions for approving the \$50,000.00 appropriation and for use of the City facilities. He thanked the City Council and Mayor for helping with the Birth Center and for their support.
- 8) Erik Cortinas, on behalf of the Fairhope Pirate Booster Club, addressed the City Council regarding Agenda Item Number 27; Resolution for approving the \$35,000.00 appropriation. He thanked the City Council and Mayor for their support.

She is an active member of the Jess Andrews, Jr. Detachment of the Marine Corps League. Ms. Thomas serves as Adjutant, is a member of the Ways and Means committee, a member of Board of Directors, and official local Toys for Tots Coordinator.

Ms. Thomas thanked the City of Fairhope for this award. She also thanked the selection committee, Marine Corps, and her husband and son for all of their support. She said that others who have won this award did so much more to serve their country. Ms. Thomas served during Desert Storm but is not a combat veteran.

Councilmember Ford commented his committees are doing just fine.

Council President Burrell explained the labor cost adjustment for the Utilities; and went over the percentage for each Utility. He stated this factor is extremely justified. - Prescription Assistance This program allows under-insured and non-insured persons to receive life sustaining medications at reduced or no cost through pharmaceutical companies indigent care program. EMI also provide prescription assistance through the Ozanam Charitable Pharmacy in Mobile.
- Church-based Community Organizing This program empowers poor and moderate income families to participate effectively in our democratic system and allow community members the opportunity to address the issues affecting their lives: paved streets, lighting, sewage, recreation and drainage.

• EMMY'S Thrift Shop – Through our emergency aid center vouchers are given at no cost. With these vouchers, people can receive such items as appliances, furniture, clothing, etc.

WHEREAS, Ecumenical Ministries Incorporated has served Fairhope residents since 1969 on a continuous basis and successfully demonstrated the capacity to operate a neighborhood based on social service agency improving countless lives.
